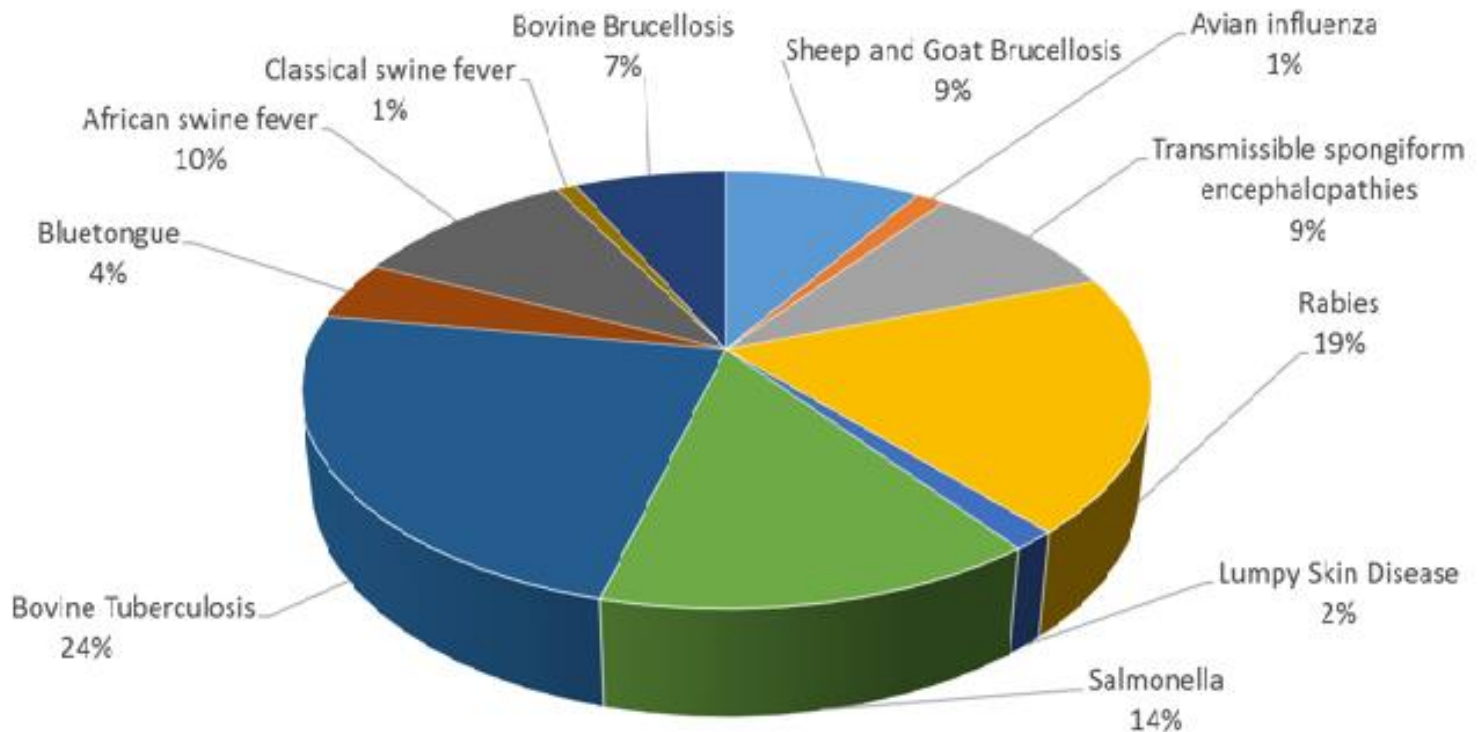

Breakdown of budget allocated per disease



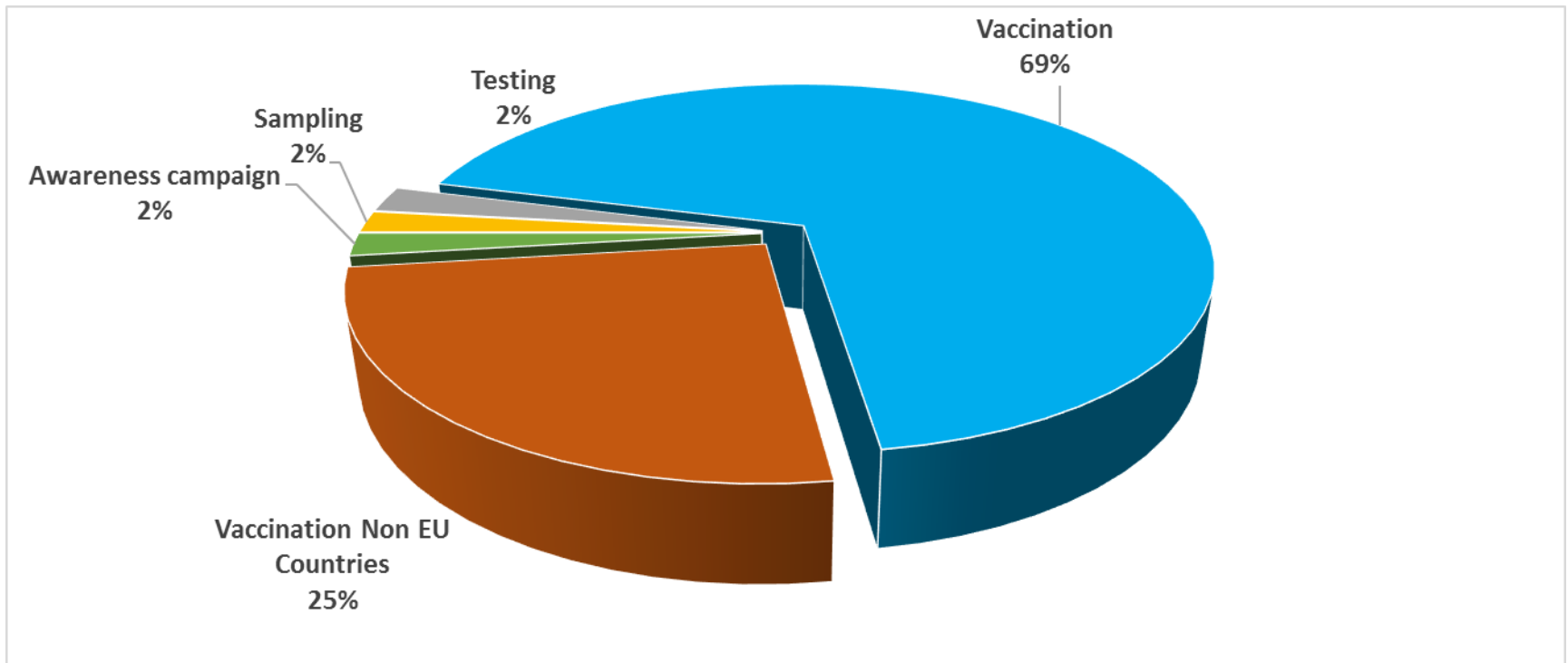

Legal basis

- **Regulation (EU) No 652/2014**
("Common Financial Framework" - CFF)
 - ***national programmes***
 - ***emergency measures***
- Commission Implementing Decision (EU) 2015/2444
 - *requirements for submission of national programmes*
- Commission Implementing Decision (EU) 2015/144
 - *procedures for emergency measures*
- Commission Implementing Decision (EU) 2016/969
 - *reporting requirements for national programmes*
- Commission (multi)annual work programmes

Financial contribution from the EU in Member States

- Maximum rates of co-funding (grants)
 - max. 50% of the eligible and incurred costs
 - *purchasing & distributing vaccine baits*
 - *sampling*
 - *laboratory tests*
 - *awareness campaigns*
 - reinforced support from 2010 – max. 75% co-funding in respect of:
 - cross-border activities (≥ 2 Member States)
 - Member States with GNI per capita $< 90\%$ of EU average
 - 100% rate possible under certain conditions

Financial contribution from the EU in neighbouring non-EU countries

- Legal basis – Regulation (EU) No 652/2014
 - Article 12(3) – national programmes
 - Article 6(3) – emergency measures (exceptional)
- From 2010: 100% funding of oral rabies vaccination (ORV) in buffer zones in non-EU countries
- From 2016: 100% funding of tests
 - provided that tests are carried out in Member States' laboratories

National programmes (non-EU countries)

- Bilateral contacts between EU Member State (EU MS) and neighbouring non-EU country authorities
- EU MS includes ORV in the border area in its programme and submits it to the Commission
- Commission evaluates/approves the programme
- Bilateral agreement (EU MS – non-EU country):
 - technical requirements
 - reporting requirements
 - funding details

National programmes (non-EU countries)

- Basic requirements
 - Technical
 - e.g. vaccine, distribution method, density, effectiveness monitoring/surveillance, etc.
 - Reporting
 - e.g. GPS distribution maps, results of monitoring/surveillance, deadlines, etc.
 - Funding details
 - e.g. invoices, maximum limits applied, timing, etc.

National programmes (non-EU countries)

- Payments
 - Through the neighbouring EU MS
 - Final payment subject to:
 - respect of reporting requirements
 - correct technical implementation (as described in agreement and approved programme)
 - financial controls
