









The EuFMD Workplan, III Pillars and 16 components

The Strategic Plan has 3 Pillars of Action, and approximately half of the budget (8 subprojects) directly support preparedness of Member States (Pillar 1).


















The EuFMD Workplan, 3 Pillars and 16 components

Pillars 2 and 3 focus on the Neighbourhood Risk, and support the GF-TADS Global Strategy.


















The EuFMD work plan, 3 Pillars and 16 components








Multi- country modelling pilot project

- The Australian FMD model (AADIS)* will be adapted provide a robust, flexible training tool to support FMD planning, training and response by European countries
- EuFMD will work on a pilot with several central European countries
 - Italy, Austria, Croatia, Hungary,
 Romania and Bulgaria
 - possibility of Slovenia and Czech
 Republic may join






EuFMD Training, October 2017

After a busy period of workshops and Real Time Training in the Spring, there has been a focus on development and delivery of e-learning across the three Pillars from May-October

- 1000 new users joined the e-learning site since General Session in April (Now >5500 independent trainees)
- 12 e-learning courses (4 week duration each) delivered since last Executive Committee meeting
- Around 40 Courses planned in next 24 months!
















New initiative – EuFMD with OIE Training on the use of the OIE Code

Why is this training needed?

- Code articles and Principles enabling safe trade are often misunderstood or not applied by countries not recognized as free of FMD;
- Principles of FMD regionalization (Containment Zones) are not well practiced in non-EU countries.
- Development of national FMD risk reduction strategies require good understanding of how the PCP and Code are complementary and synergistic

Course 2. FMD Containment Zone Training Course















What's next?

Pillar I

- Call for nominations for training 2017-19: 10 new credits per country
- Regional training initiatives, continued support to national training

Pillar II

- After intensive period of development move to delivery focus, including translation of courses to French and Russian
- Continued development of Arabic language courses/resource for field level
- New course development working with OIE on safer trade

Pillar III

- Training support to FMD working group
- Further develop training relationships with South Asia, and new region of West and Central Africa













DRAFT Course 1. Safe trade and FMD Control Training Course

The audience: Mainly non-free countries and non-EU countries

→ 4 days workshop (with field trip on zoning-based control) preceded by an e-learning (using existing EuFMD e-learning content supplemented by some short new material);

Topics covered in the workshops:

- **Day 1.** Impact of FMD on trade. Market access negotiations, veterinary certificates.
- **Day 2.** Trade between countries. Zoning, compartmentalization.
- **Day 3.** Simulation exercise on understanding of "real-life" transmission risks
- **Day 4.** Disease risks from the import of animals/animal products. Commodity-based trade

Outcome: Analysis of the feedback from the workshop will lead to the development of an E-learning course covering major gaps















DRAFT Course 2. FMD Containment Zone Training Course

The audience: FMD free countries, Non-EU countries and FMD free countries of Southern Africa, East Asia, South America

4 days workshop with field trip preceded by an e-learning on the principles of the containment zone (using existing EuFMD e-learning content supplemented by some short new material);

Topics covered in the workshops:

- **Day 1.** FMD outbreak and a Containment zone. FMD outbreak scenario development.
- **Day 2 and 3.** Field trip with the roles and action plan on establishing of a Containment zone.
- **Day 4.** Status suspension, official recognition of the zone, trade continuation, regaining of a free status

Outcome: Assessment of the crisis and managing a risk, development of an approach to control FMD by a rapid response.
