Change in the ASF epidemiology since the SGE1 (Minsk, December 1-2 2015)

No cases in domestic pigs.

Since September 2014 103 cases in wild boars (80 dead, 23 hunted)

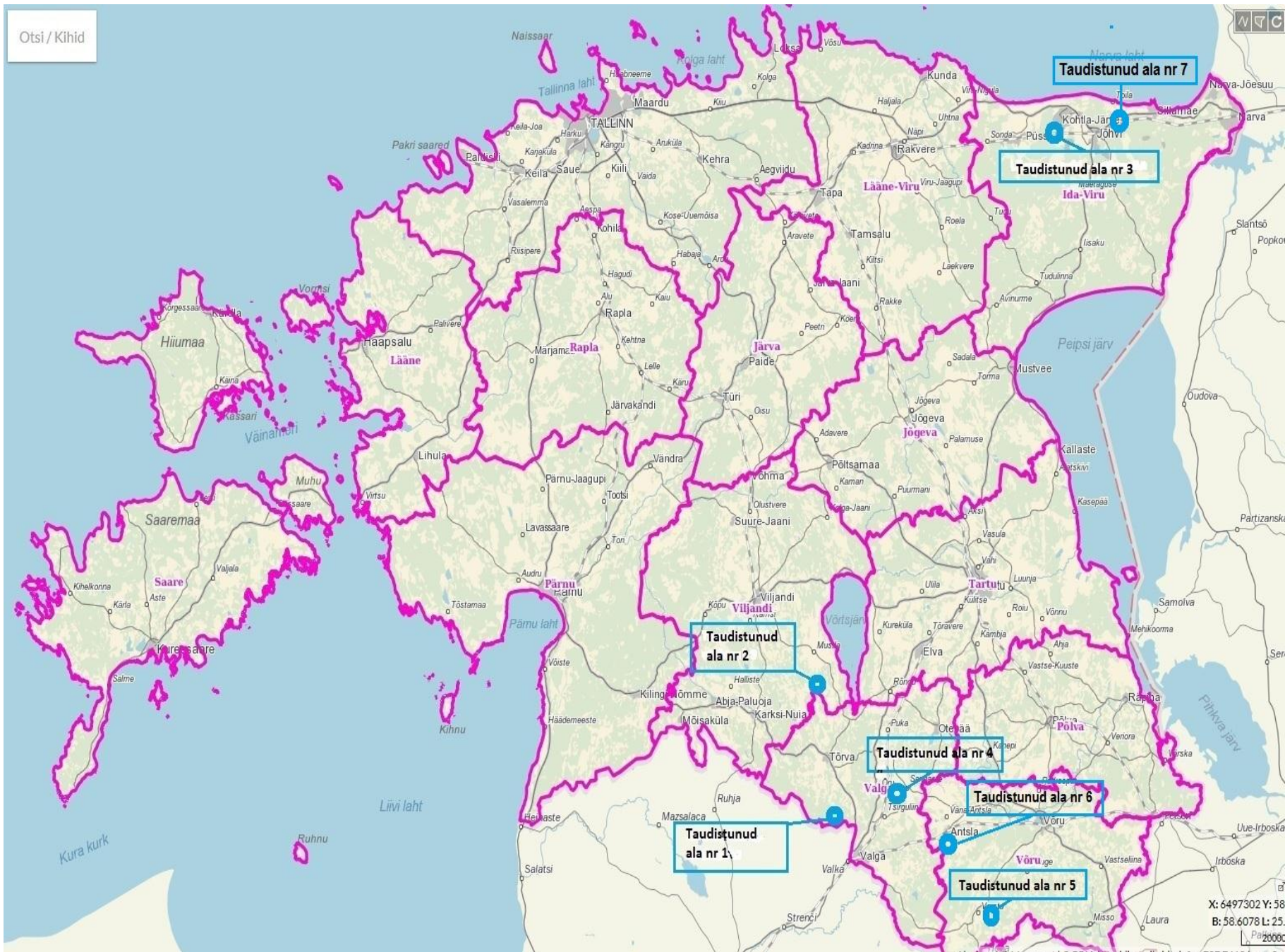
Cases distributed between 7 clusters (200 sqkm) in southern and north-eastern Estonia

2014 – 1056 WB samples, January 2015 – 498 WB samples

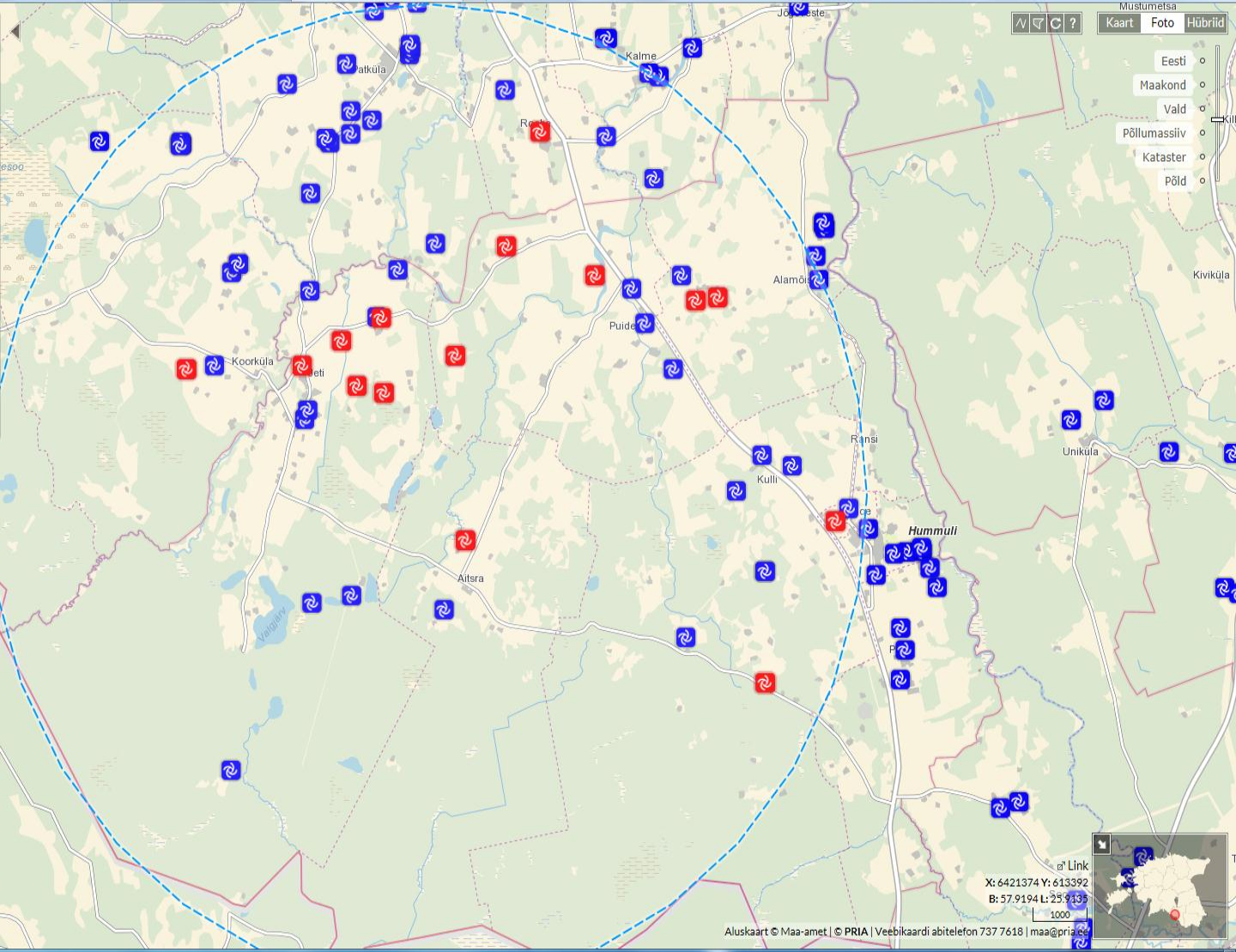

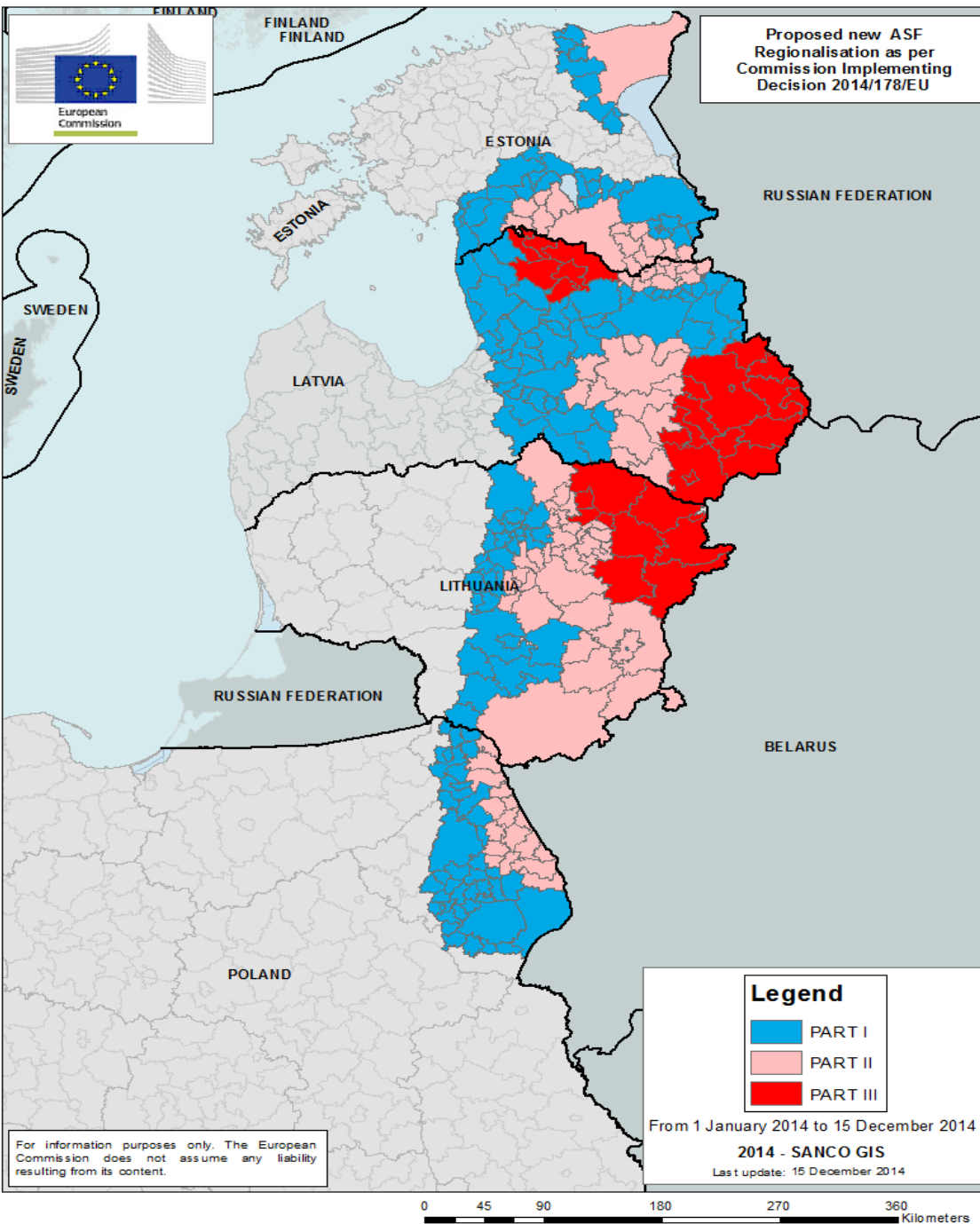

Revised strategies for ASF control in wild boar

- Decree of the DG Environment Board from 30.09.14
Driven hunt and hunt with dogs in part II areas are forbidden. No new feeding places.
- Decree of the DG Environment Board from 30.10.14
Obligation of veterinary confirmation on sampling for ASF on hunting licences in parts 1 and 2 for hunted wild boars

Biosecurity aspects in pig farms - additional efforts since 2014

VFB DG Decree from 25.07.14 Ban on outdoor farming of pigs

Meetings of central and regional crisis commissions

August 2014 – 100% inspection of pig holdings (920 holdings with 38000 pigs. 2400 pigs in holdings with less than 10 pigs)

Awareness campaigns, meetings with farmers and hunters.

Biosecurity in par 7 Law on Animal Health

Controls over movements of people and vehicles

Restricted access for unauthorised persons

Restricted access for any person travelling abroad for 48 hours
after return

Initial separation for new animals introduced into the herd

Separation for disease suspect animals

Regular disinfection on surfaces and equipment and management
system for feed, bedding.

Regular desinsection and deratisation

Restricted access for any domestic animals or wildlife.

Other biosecurity aspects

Par 57 Law on Animal Health

Veterinary and Food Board can refuse the application for compensation –

Applicant has not fulfilled imposed restrictions, has restricted the activities of veterinary authority.

Other biosecurity aspects

Inspection of all pig holdings once a month in 200 sqkm infected zones

Swill feeding is prohibited

No live pig markets

All fallen livestock reported, collected and rendered by state owned rendering plant.

Continuing collaboration with Tax and Customs Board for 100% controls of personal luggage at land border

Other biosecurity aspects

December 2014 - locked containers in clusters for dead and hunted positive WB collected and rendered by state.

January 2014 – disposable rendering unit.
