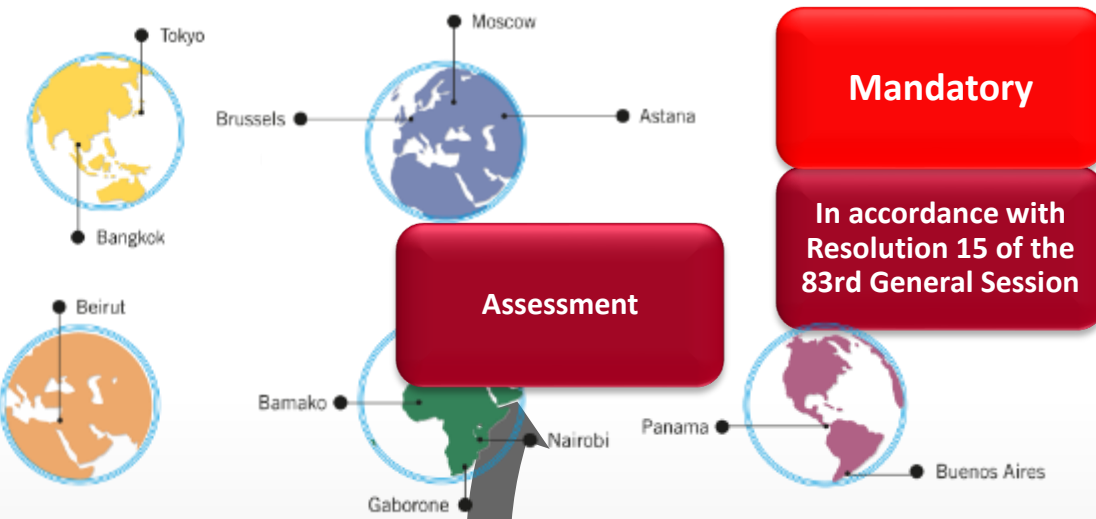

- Maintain the compliance with the requirements of the *Terrestrial Code* for FMD
- Annual reconfirmation mandatory for Members having an officially recognised FMD status or a validated official control programme

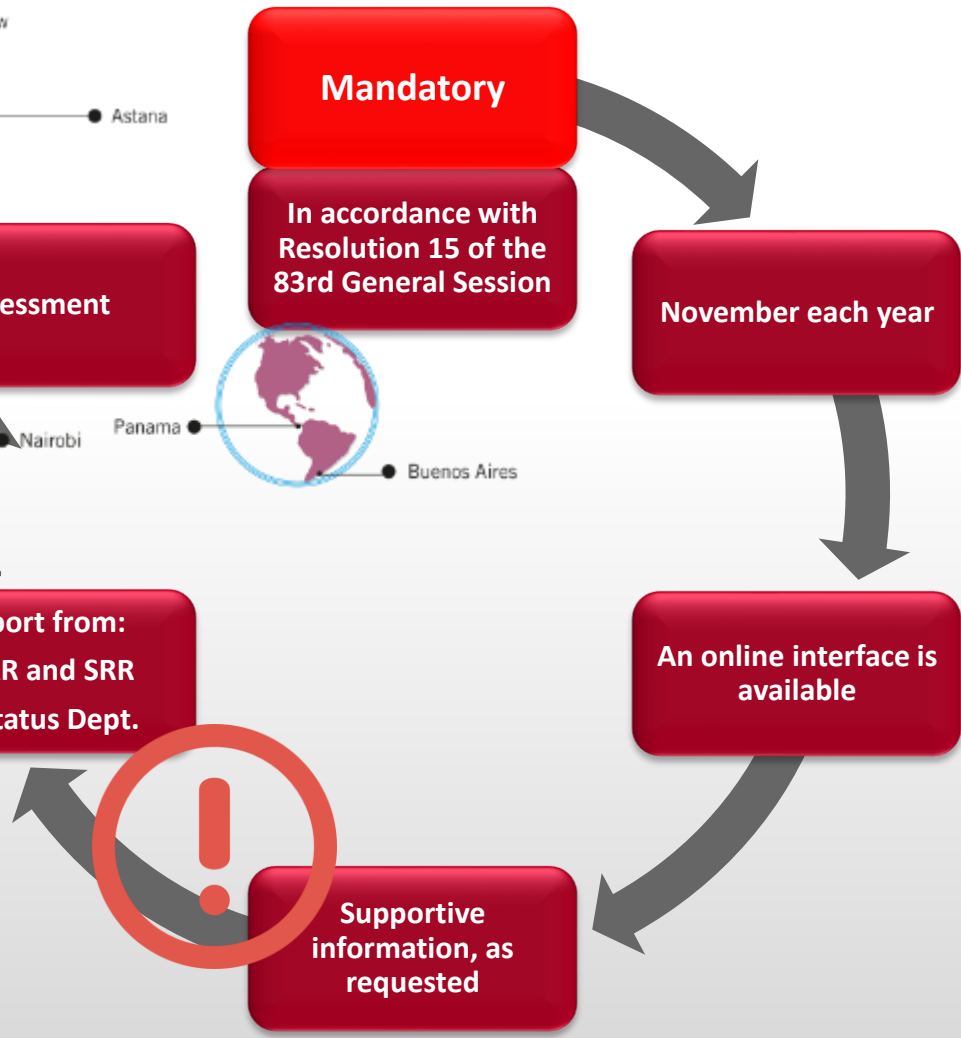

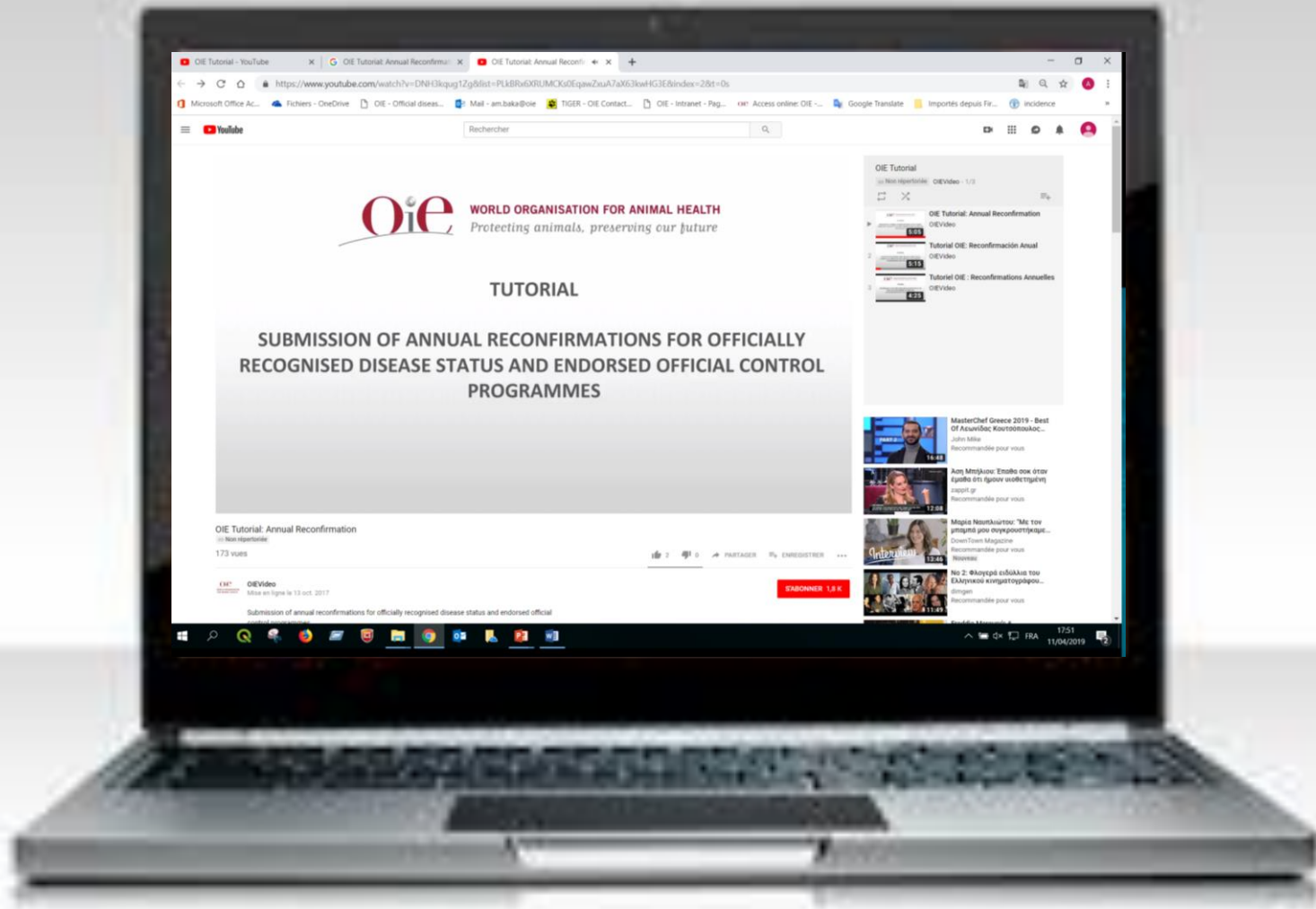
Standard Operating Procedure on the reconfirmation of officially recognised disease status and of the endorsement of national official control programmes of Member Countries

Description/ Scope:	<p>This procedure describes the process for the submission of annual reconfirmations for the maintenance of official disease status or endorsed official national control programmes.</p> <p>The subprocess for the reconfirmation of a status or of an endorsed control programme fits in the overall Official Status Recognition Process.</p>

- Member Countries having an officially recognised disease status or BSE risk status should reconfirm every year, during the month of November that remained unchanged,
- Member Countries having an officially endorsed control programme should inform the OIE during the month of November on the progress on the in the control programme.

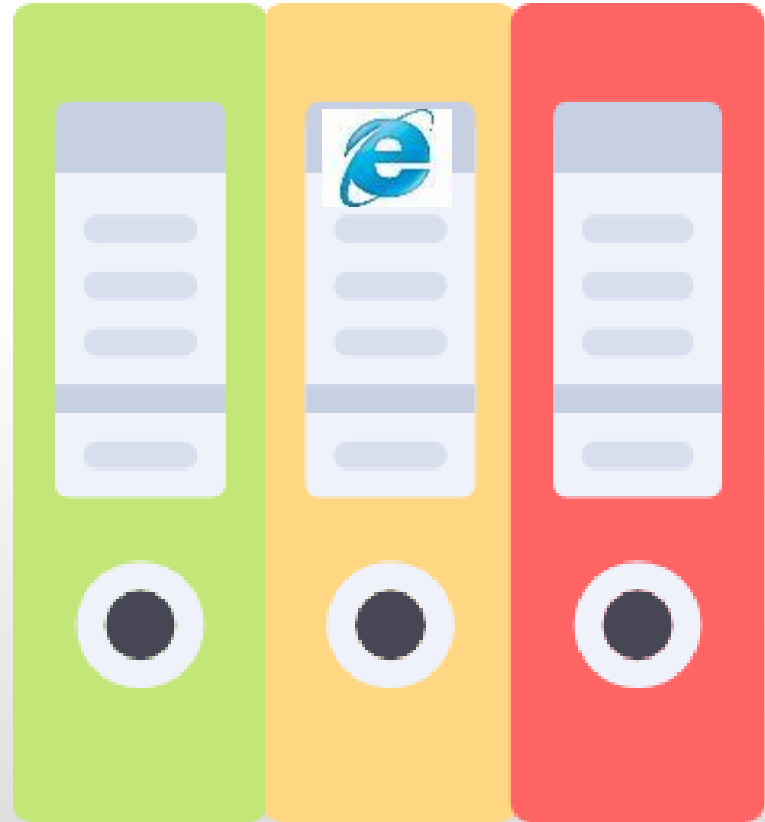

- Brief description of the overall surveillance system, including the early detection system
- Clinical surveillance:
 - Summary table indicating over the last 12 months, the number of suspected outbreaks, number of samples tested for FMDV, species, test methods and results (including differential diagnosis)
 - Details on follow-up actions taken on all suspicious results
- Serological and virological surveillance, when relevant
- Information on the system in place for preventing the entry of FMDV; the control of the movement of susceptible animals and their products into the FMD free country; and the absence of introduction of vaccinated animal.

 - List of the timelines for the programme that had to be met over the past 12 months. In case a timeline has not been met, explanation on the cause and corrective actions

- Details of performance in inter-laboratory validation tests

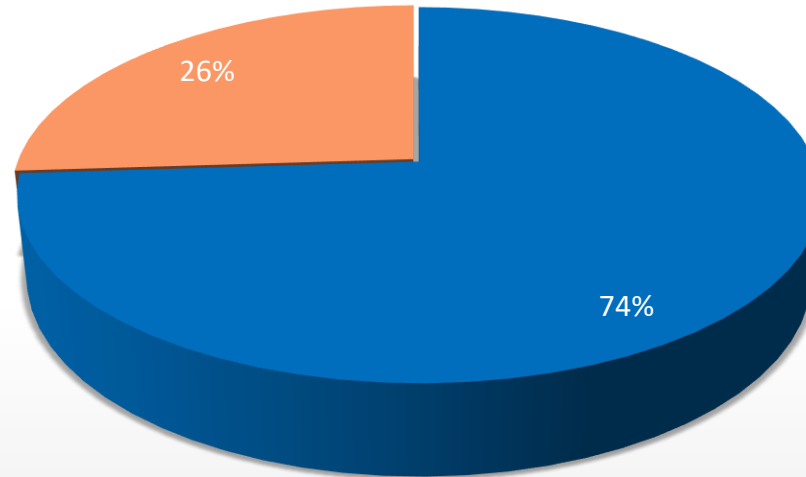

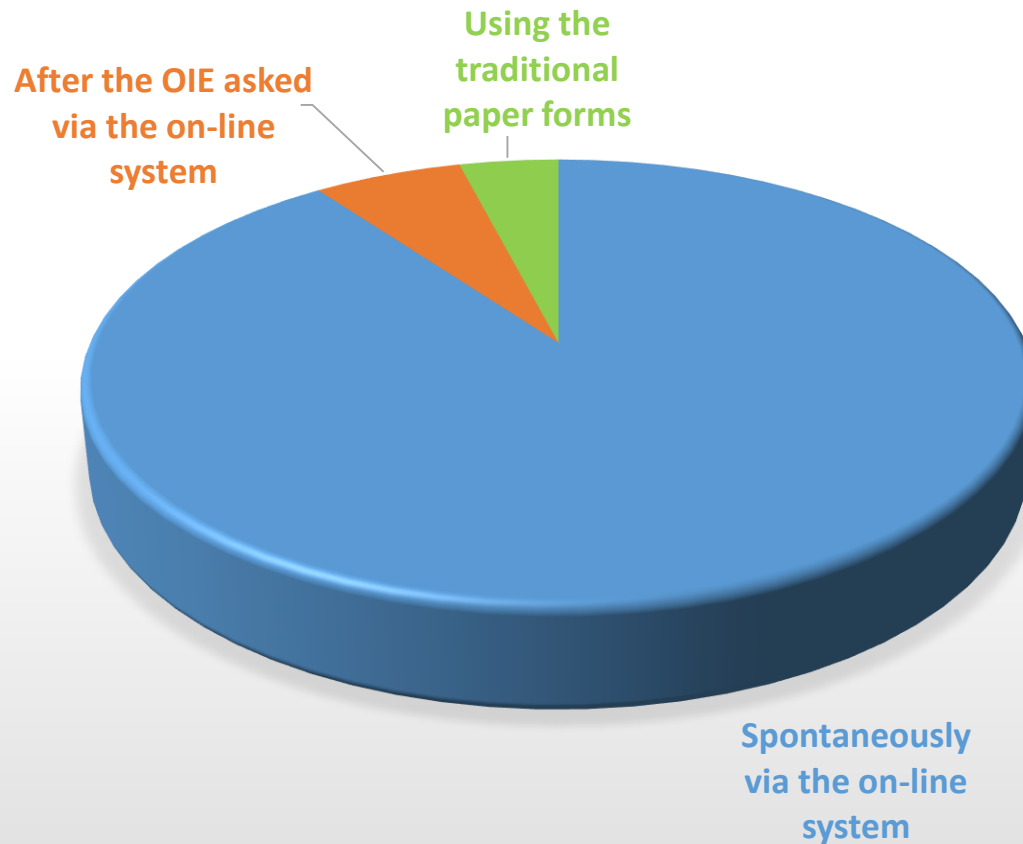
Date of submission of reconfirmations by Europe
