






1st Multi-regional WJS workshop on long-distance transport by land and sea between Europe and the Middle East 21st June 2021 - Online



Chapter 3.1 of the OIE TAHC "quality of Veterinary Services"

- VSs should play a leadership role in advising the various authorities on AW (and AH and veterinary public health) in disaster situations
- VSs should develop and document appropriate procedures and standards for all providers of relevant activities and associated facilities, particularly in relation to preparedness and response to natural disasters which could have impact on AH and AW



The Table Top simulation Exercise (TTX)

- This Table Top Exercise (TTX) aimed at testing and validating model Veterinary Service's Contingency Plans (VS-CP) for the management of animal welfare matters in a flooding scenario whilst identifying issues and improvements of protocols and operational procedures employed in managing the event;
- Romania kindly provided a translated version of their Contingency Plan and contributed to develop the scenario;
- This training event explored the implications for contingency planning to protect the welfare of livestock, wildlife and guarantee companion animal's welfare assistance during and after natural disasters, using the example of a flooding scenario;
- Preliminary results of OIE/LMU survey on VS's preparedness on DMRR in 53 European MCs were presented 92% of country responded to the questionnaire;
- Representatives from: Albania, Bosnia, Bulgaria, Croatia, Greece, Kosovo*
 Montenegro, North Macedonia, Romania, Serbia- 2 OIE CC, LMU (USA)
 NGOs ,Industry.



Outcomes/results

- This was the first time a dedicated team of experts reviewed a Contingency
 Plan on animal welfare in a flooding scenario highlighting its strong points and
 identifying areas of improvement;
- Targeted Balkan countries can further enhance their management and response capacity on AW during natural disaster situations, with their VS-CP for hydrological disasters developed, known from relevant CAs and tested-Romania;
- They also have better understanding how to mainstream VS matter in the National DMRR Plan.



Fourth Regional workshop on Stray Dog Population control for Balkans Countries (SDB4)

30 November 2021 – Online



Specific country needs raised at the SDB3 in 2018 and expected targeted support in between workshops

- Funds, budgetary resources (programs funded by donors / resources partners (i.e., wildlife rabies control is funded by EU)
- Training programs, workshops (new specific topics to be addressed during the next SDB workshop, possibility for developing online training modules)
- Development of National Control Strategy / Development of regional/municipal stray dog strategies (political and financial commitments + technical assistance)
- Education and awareness/ Establishment of raising awareness campaign at municipal level (involvement of national FPs on communication)
- Development of a comprehensive database for dog shelters
- Implementation of Identification and Registration IT systems at national level
- Training on methodologies for counting the number of stray dogs
- Strengthening regional and national collaboration and communication mechanisms
- Technical assistance (sharing countries experience, OIE CC, RAWC, Task force)
