- National AW strategy (development and implementation)

## Current developments on Dog population management system

- 3 year 2018-2021 National AW strategy with action plan, approved by the government
- 5 priorities (Animal transport, AW during Slaughter Laying hens, DPM, Raising awareness campaign)
- One of the priorities is Dog population management and establishment of raising awareness campaign on responsible ownership
- 100 000 microchips supplied intended for I&R of owned dogs.
- 147 Private veterinarian practitioners contracted for application of the microchips and entering the data into National Veterinary Informative System

- 32822 microchips dedicated to the municipalities

#### New legislation (2021)

- New Book of rules on catching, interventions and treatment of stray dogs, technical conditions in shelters, test on socialization on stray dogs, euthanasia and data recording
- BoR on test on socialization of dogs
- BoR on Authorisation on persons who condust the test on socialization (20 persons authorized)
- BoR on the training of owners of dangerous dogs



#### Dog population control programmes (DPCP)

- The municipalities should issue dog population control programme (approved by FVA)
- According to the new legislation that is drafted this year, the DPM plans should be drafted according to the dog estimation survey.
- The FVA approved 37 programmes in 2019, 7 in 2020 and 12 in 2021



#### Dog population control programmes (DPCP)

- 17 shelters approved, In the Capital Skopje, newly Shelter (capacity of 120 dogs).
- 44 from 80 municipalities have contract with approved shelter and actually work on DPM
- The municipalities work on CNVR principle



#### Dog population control programmes (DPCP)

- Every stray dog, in the shelter should be checked on aggression.
- Authorized and trained person (DVM, Police or army dog trainers), 20 authorizations so far.
- The dogs which is aggressive can not be returned on the location (must be kept for 30 days to attempt to rehoming)



#### Raising awareness campaign

- Communication strategy issued
- Printed materials (posters), Bilboards
- Promotive materials
- Education in primary schools
- Media campaign

































#### CHALLENGES
