

- Ongoing review and harmonisation of OIE Terrestrial Code Animal Welfare Chapters.
 - ➤ New Chapter 7.Z. Animal welfare and laying hen production system. Not adopted during the 88th OIE General Session in May 2021.
 - Chapter 7.7. Stray dog population control (Dog population management) proposed for comments and adoption at the 89th GS in May 2022.
 - Revision of Chapter 7.5 slaughter of animals (Animal Welfare during slaughter). Code Commission request the ad hoc Group will be reconvened to discuss Member Country comments.
 - > Start of the work on the revision of the Terrestrial Code chapters on the welfare of animals during transport by land, sea and air (Chapters 7.2, 7.3 and 7.4).





OIE TAHC CHAPTER 7.7. DOG POPULATION MANAGEMENT REVISION PROCESS



WHY DID THE OIE DEVELOP THIS CHAPTER?


- More than 55 000 people die each year from rabies. A majority are children and in many cases the source of infection is a stray dog.
- > 99% human rabies deaths due to dog bites
- Many millions of animals contract and die of rabies each year.
- > Stray dogs pose serious human health, animal health, animal welfare, socioeconomic and political problems in many countries of the world, and especially in developing countries and in least developed countries.

REVISION PROCESS

Background

The main objectives of reviewing Chapter 7.7 is to provide clear guidance on DPM considering animal welfare aspects, to support implementation of disease control programmes, in particular for rabies control, to give recommendations on DPM in case of disaster management, and to provide tools for interventions where dog populations pose a risk to human and animal health, welfare and security.



REVISION PROCESS

Background (Cont)

- During 2020 the ad hoc Group on the revision of Chapter 7.7. Stray dog population control met eleven times virtually to finalise the revision of the chapter in accordance with the Code Commission's advice from its February 2020 meeting.
- Member countries have had one opportunity to comment.
- ➤ In 2021 the ad hoc Group met four times to address Member comments in accordance with the Code Commission's advice from its February 2021 meeting.

After the September Code Commission meeting:

- ➤ The revised Glossary definition of 'Stray dogs' is presented in Annex 4 for Member comments.
- ➤ The revised Chapter 7.7. Stray Dog population control is presented as Annex 9 for Member comments and is proposed for adoption at the 89th General Session in May 2022.

SUMMARY REVISION PROCESS

Definition

To replace the current definition of 'stray dog' with 'free-roaming dog' in the Glossary. This definition, as the change of the title, considers all categories of dogs under the scope of the revised chapter and described the behaviour of a dog which is roaming without restriction but does not imply any ownership status.

Main aspects considered in the revision

- In this revised structure, articles were either added or reorganised to improve the flow of the recommendations and to address the wider scope of the chapter. In particular, the articles on roles and responsibilities were rewritten to reflect the various entities who may have a role in DPM.
- > The terminology used throughout the chapter and title was harmonised to be consistent with the terminology used in other texts and with other animal welfare chapters.

SUMMARY REVISION PROCESS

Main aspects considered in the revision(Cont)

- > The scope was redefined to focus on the welfare of dogs when implementing dog population management programme.
- The objectives of this chapter were reworded and updated to take into consideration the OIE's activities around dog-mediated human rabies.
- > As for the structure, the content of each article was revised to ensure most up-to-date guidance on DPM.
