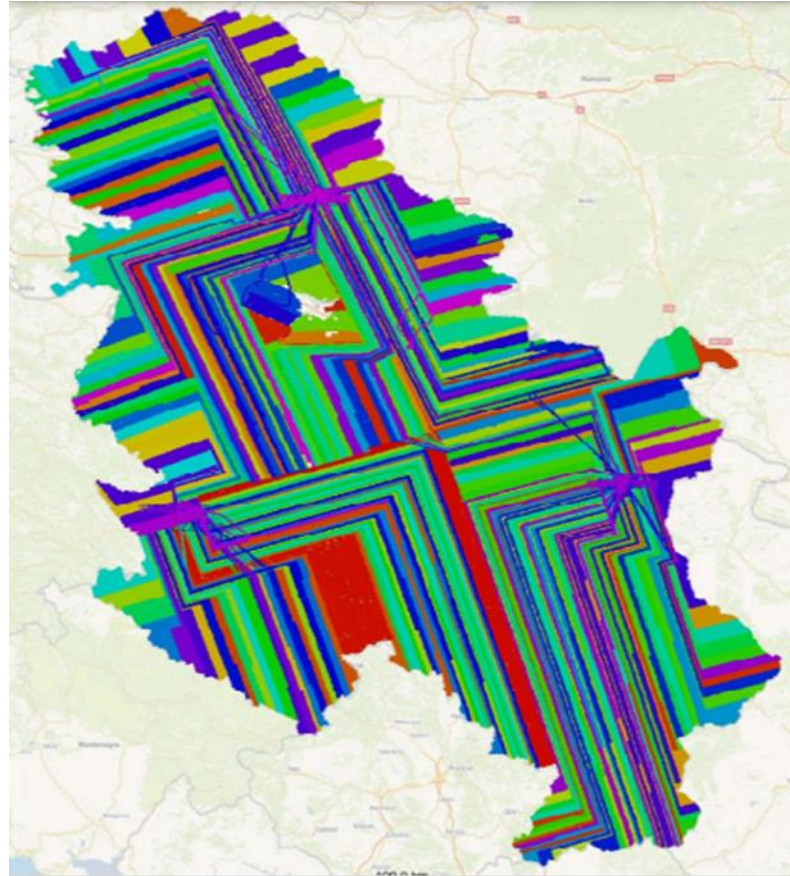

Only needed if it is not the whole country

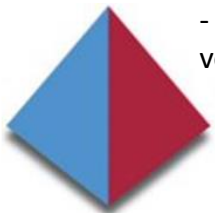
