II. Control measures

NO on national level

Program for the control and reduction of the population of abandoned dogs and cats in accordance with specific characteristics of environment – Article 54 of the Animal Welfare Law obligation of the local government

Main control measures implemented in Republic of Serbia
- legislation/ primary and secondary
- responsible ownership
- identification and registration (transponders, ISO standard)
- surgical sterilisation
- appropriate shelters, registration
- control movements
- registration of breeding establishments
- reduction of bites incidence-responsibility of the owner
- licence of dangerous dogs
- euthanasia is allowed - serious or incurable disea - euthanasia is allowed transmission/AW reasons diseases/desease



III. Monitoring and evaluation

- control of implementation of the Animal Welfare Law
- animal health control
- registration of animal sheltersregistration of breeding establishment
