Education in primary Schools

From the beginning of the campaign, 25 primary schools visited Mixed educational team-FVA and the Faculty of veterinary medicine Skopje









Activities

 OIE ToT on AW during Slaughter and transport of animals (Skopje, Tirana, Sarajevo)-Involvement into the organization in the workshop held in Skopje



Activities

National (3 Year) strategy on animal welfare is adopted with 5 priorities defined:

- 1. Animal welfare during transport-authorization of transporters process
- 2. Animal welfare on stray dogs
- 3. Animal welfare in the slaughterhouses (focus on slaughtering of lambs)
- 4. Animal welfare of laying hens
- 5. General animal welfare raising awareness campaign



- Veterinary informative system on I&R on dog and cats established
- 100 000 microchips supplied (free for dog owners), up to this moment approx. 60 000 dogs is identified and entered into the database.
- With collaboration with the RSPCA approx. 150
 persons trained (official veterinarians, Army,
 Police, private vet practitioners and dog shelters)



- 21 out of 23 AUDITS into the slaughterhouses performed (2 AUDIT teams-in each team one official from the FVA was included into the OIE ToT training on AW on Slaughter and transport of animals)
- The FVA authorized Institution which will issue the certificate of competence for animal welfare officer (2 Trainers-OIE ToT training on AW on Slaughter and transport of animals is engaged)



- Authorization of transporters Screening of the situation performed
- The FVA authorized Institution which will issue the certificate of competence for drivers and attendants
- Brochure on animal welfare during transport printed in 1000 copies
- Official veterinarians trained
- The process is foreseen to finish to the end of 2019



- General Raising awareness campaign (general public, farmers, responsible ownership, ritual slaughter, transport of animals, AW on working equids etc.)
- Communication strategy in draft process/implementation process is foreseen to be in 2020
