

SAM4DPM User Guide for the Competent Authority (CA)

Introduction

Since 2014, the WOAHP Platform on Animal Welfare for Europe Action Plans has implemented a series of capacity building and technical support initiatives aiming at supporting the implementation of the Chapter 7.7. of the Terrestrial Animal Health Code (TAHC), in order to mitigate risks to public health, livestock losses, wildlife conservation, and dog health and welfare in the region.

In this vein, the WOAHP in collaboration with the Istituto Zooprofilattico Sperimentale dell'Abruzzo e del Molise/WOAHP Collaborating Centre have developed an upgraded version of the stray dog Self-Assessment and Monitoring tool (SAM Tool 1.0) – used in the past to establish and monitor the progresses achieved in the implementation of the former Chapter 7.7. recommendations on stray dog control - in the format of a web-based self-assessment platform now renamed **Self Assessment and Monitoring System for Dog Population Management (SAM4DPM)**.

The new SAM4DPM is fully aligned to the revised Chap. 7.7. on dog population management and can be easily tailored for implementation in various regional or sub regional contexts. It is an user-friendly automated self-assessment and data analysis system, that automatically generates reports made of schemes and graphics upon need, in order to provide a more detailed and live time understanding of the overall situation at national level. It also enhances the opportunities to collaborate with partners/stakeholders in a comprehensive and intersectoral manner, by giving evidence of the progressive level of implementation of TACH Chapter 7.7. on dog population management and Chapter 8.15. on infection with the rabies at country, multi- country, or multi-regional level.

Main objectives of this tutorial, primarily targeting the contact persons tasked to manage the system as Country Profile Administrator (CPA) are (1) to present the new SAM4DPM system functions, relevant tools and outputs and (2) to facilitate the self-assessment rounds to be done in preparation to the forthcoming regional workshops on dog population management organized in the frame of the 4th Action Plan (2024-2026).

The Country Profile Administrator (CPA) will be provided with this user's guide and the keys to access the SAM4DPM reserved area, that can be reset and automatically recovered if necessary. The CPA will be able to generate tokens to let other subjects at local/peripheral level (within the same country) accessing the platform and complete other complementary forms, and consult reports.

The SAM4DPM currently allows to:

- Update data and information upon need;
- Process data 100% electronically at country and multi-country (or multi-regional) level for reporting purposes;
- Use the information and data already provided in previous assessment round(s);
- Generate automatically Country reports (PDF and Word files) made of schemes and graphics showing the level of compliance with Chap 7.7. and Chap 8.15. of the WOAHP TAHC.

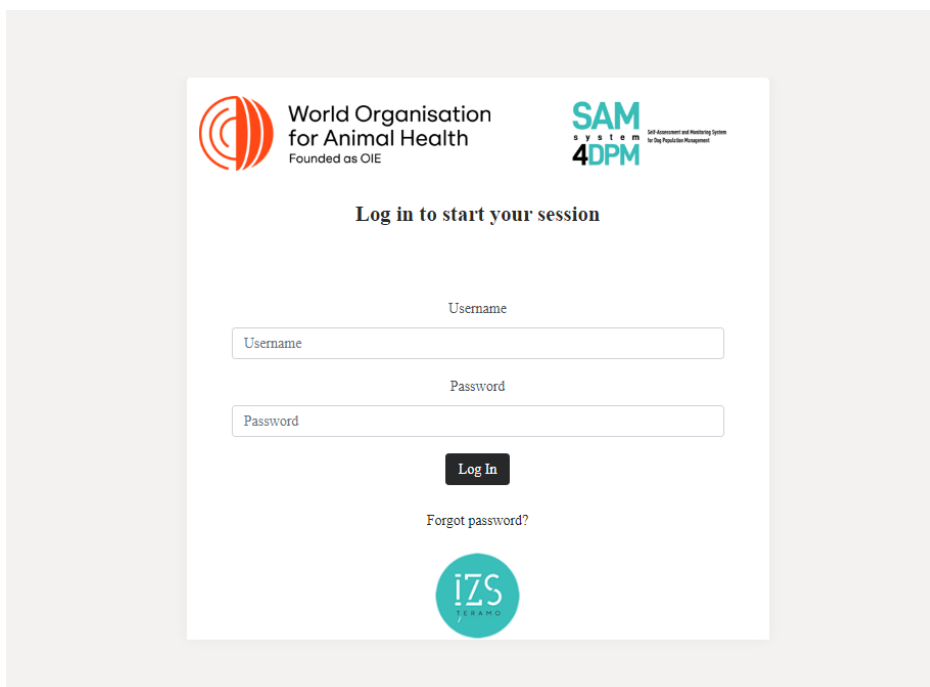

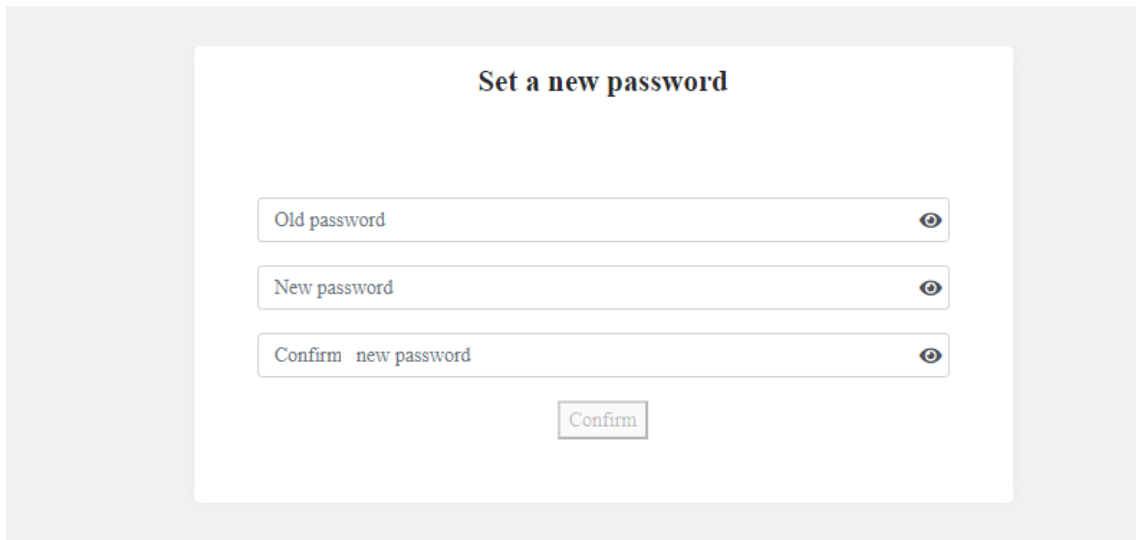
Step 1. Create your credentials

1.1 Go to the following link <https://samsystem.izs.it/> and log-in with your username (your email) and the password you received via email by samsystem@izs.it

1.2 Now you will be requested to create a new password to complete your first access.

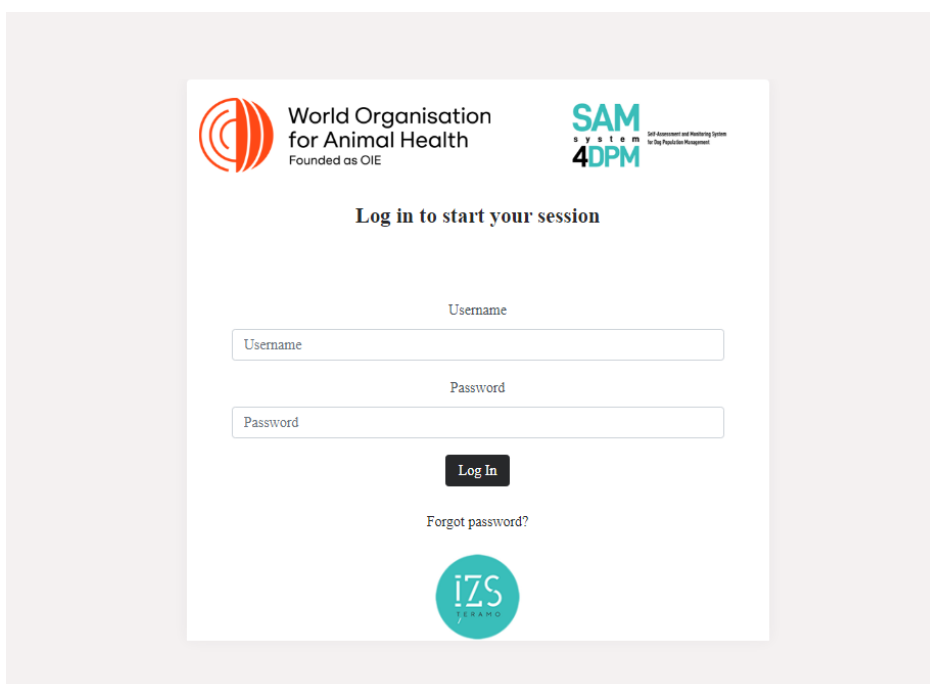
