- 5. Follow the timeline for dossier submission agreed during the workshop
- 6. Georgia to finalize the testing of PMAT e-learning and provide online feedback.









Countries update:

Kyrgyzstan – PPR mission request (laboratory assessment and strategy assessment).

REU's mission to Kyrgyzstan planned. PPR to be covered. Ready to apply a dossier

Kazakhstan – REU's mission to Kazakhstan planned. PPR to be covered. Ready to be next for dossier

Iran – PMAT update

Uzbekistan – good communication platform

Azerbaijan – Dossier has been submitted.

Ready to share the experience in dossier preparation with countries

Georgia - Support to Georgia for emergency vaccination.

Tajikistan – with no support of FAO, it is difficult to move forward

Turkmenistan – with FAO support is a platform to move forward

Armenia – start working on PPR freedom with FAO support

Turkiye - dossier rejected, using the help of expert with the new strategy and dossier.

FAO support may be needed to readjust the dossier and a strategy.
