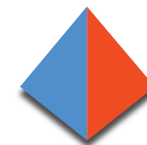
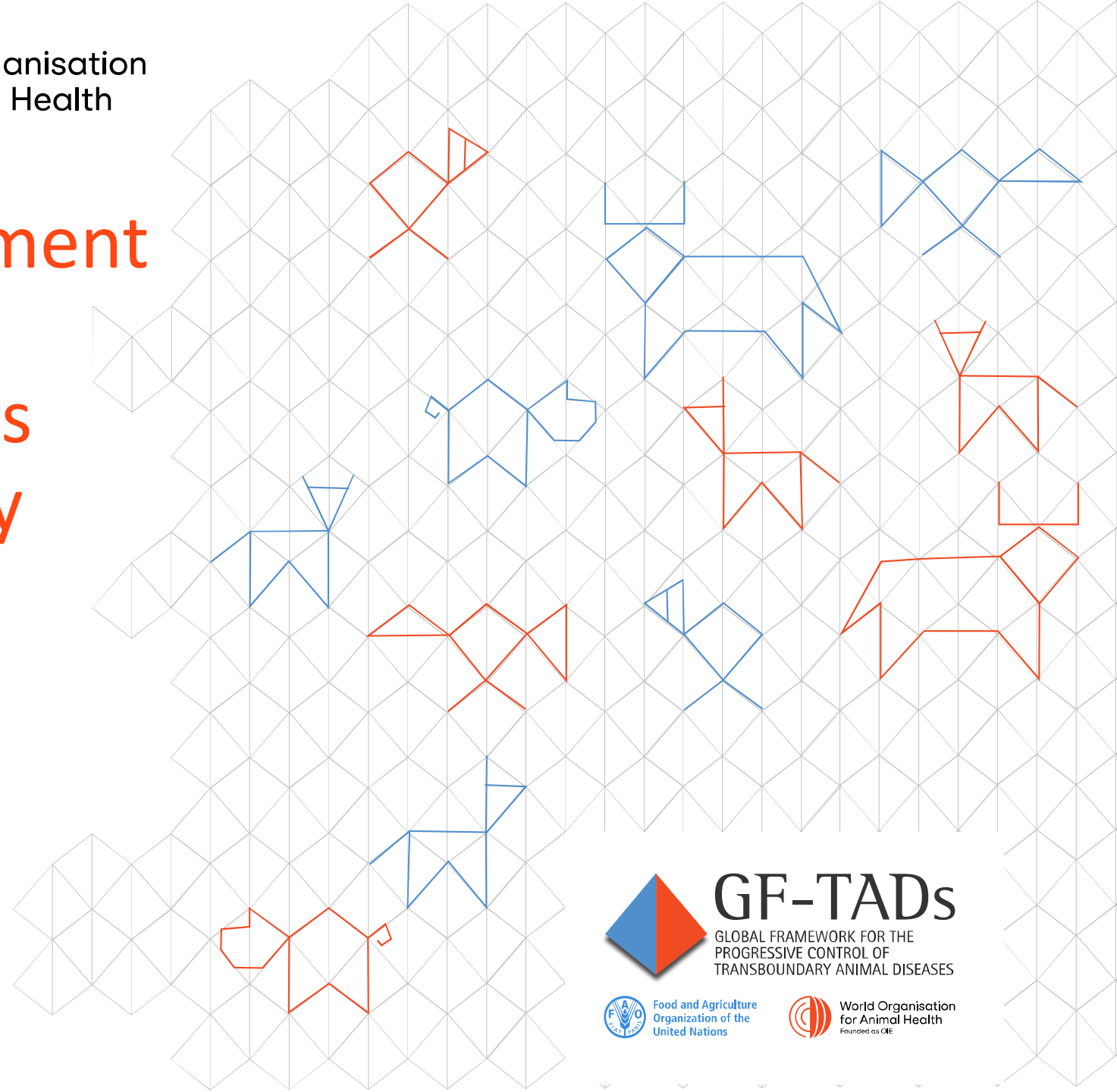

❑ The PMAT was well filled in 2023 and repeated in 2024.

❑ The country was able to fulfil requirements for official free status which was grant in 2024.

- Since the country has not detected the PPR virus in its territory, suggestion be to advise the country to carry out the necessary preparation to apply for WOAHP official recognition of PPR free status.

- They currently carry out vaccination without a clear strategy and therefore could be advised to stop vaccination and consider applying for official PPR-free status.

- ❑ The country could consider stopping vaccination and after 24 months carry out the necessary preparation including surveillance to provide adequate assurance of no virus circulation and then apply for WOA's official recognition of PPR-free status.
