



ASD-Cases in wild boar DEU

1st September 2023 – 31st August 2024

- New introduction to Hesse in June 2024 by jump (genetics: Southeastern Europe)
- Hotspot in nature reserve
- Affected border triangle to Rhineland-Palatinate and Baden-Wuerttemberg
- Last infected area in Eastern DEU and singular cases within or east the "ASF protection corridor"

special measures DEU


- ✓ Implemetion of core areas
- ✓ Frequent active search for carcasses with dog teams, drones and humans
- ✓ Fencing (white zones and ASF protection corridors)




