Implementation and enforcement – what are the main actions taken to implement and enforce your regulatory framework?

Veterinary Directorate is responsible for preparation of legislation - Laws and Rule books

Veterinary inspectors has the right and duty to check:

- conditions of animal husbandry and breeding facilities, space and premises
- fulfillment of requirements regarding welfare training
- Measures of the veterinary inspector order the elimination of work irregularities
- closing the premises within a certain period of time
- prohibit the operation of premises, if they were not eliminated in the prescribed manner deadline



Data – what data you collect and how?

Register of farms

Register of slaughterhouses

Register of experiments on animals (natural and legal person conducting the experiments)

Register of shelter

Register of boarding premises

Register of breeding establishments

Register of zoos

Collection of data received from inspections, annual reports of users



Public awareness or educational programs – What programs are currently in place in your country?

Animal Welfare Law prescribes the obligation of training in all which refers to all the areas of animal welfare

The Faculty of Veterinary Medicine is authorized to organize trainings above mentioned training

Trainnigs are prescribed by the Law on Animal Welfare in acordance with EU regulation and WOAH standards.

Include veterinarians on central level, veterinary inspectors, stuff working in the slaughterhouses in all fields related to animal welfare
