Regulatory framework and competent authorities

Animal welfare legislation:

- ✓ Law of Ukraine "On State Control over Compliance with the Legislation on Food, Feed, Animal By-Products, Animal Health and Welfare»;
- ✓ Law of Ukraine "On Veterinary Medicine";
- ✓ legal acts approved in accordance with them.

The system of executive authorities in the field of animal welfare includes:

Cabinet of Ministers of Ukraine

The central executive body that ensures the formation and implementation of state policy in the field of animal welfare Central executive body that implements state policy in the field of animal welfare (Competent Authority)







State Service of Ukraine on Food Safety and Consumer Protection (the SSUFSCP)



The main tasks of the state in the field of animal welfare are:

- > ensuring the development, approval and implementation of requirements for animal welfare;
- > ensuring the functioning of the system of training of personnel, facilities and testing of knowledge and skills in compliance with the requirements of the legislation on animal welfare;
- ensuring humane treatment of animals throughout their lives and during killing, in particular through state control in order to verify compliance with the requirements of legislation on animal welfare;
- > ensuring that the measures are taken to eliminate the identified violations of the legislation on animal welfare;
- ensuring that the analizing of compliance with the requirements of animal welfare legislation is carried out on a regular basis;
- riangleright ensuring the making and implementation of action plans to prevent violations of animal welfare legislation in the future.



National Animal Welfare Standards

By the Order of the Ministry of Agrarian Policy and Food of Ukraine dated 29.08.2022 No. 628, registered with the Ministry of Justice of Ukraine on October 14, 2022 under No. 1244/38580, the following was approved:

Requirements for ensuring the welfare of animals during slaughter and killing



Council Regulation (EC) No 1099/2009 of 24 September 2009 on the protection of animals at the time of slaughter





Competency training for slaughterhouse/abattoirs personnel

Business operators carrying out the slaughter of animals are obliged to ensure the execution of the following operations in accordance with the requirements:

- 1) handling and caring for animals before immobilization;
- 2) immobilization of animals for the purpose of stunning or killing;
- 3) stunning animals;
- 4) checking the effectiveness of animal stunning;
- 5) restraint;
- 6) bleeding of animals;
- 7) slaughter of animals in accordance with religious rites



Competency training for slaughterhouse/abuttoire personnel

What is the level of awareness and understanding of animal welfare among slaughterhouse staff in your district?

We assess the level of awareness as average in the country.

The level of awareness is high for slaughterhouses that have implemented welfare standards

What is the established training system for animal trainers and other personnel, including personnel conducting containment, stunning, and bleeding operations, in your country?

Centralized training is provided with the issuance of appropriate certificates and maintenance of a single register of persons who have received a certificate



Training and competence among veterinarians

The State Service of Ukraine on Food Safety and Consumer Protection (competent authority) provides training for inspectors of the competent authority at the central, regional, local levels, as well as organizes targeted information campaigns and trainings for business operators



Program for the implementation of the system of state control over the welfare of farm animals by the SSUFSCP

Development check lists for control (inspection acts)

Development of standard operating procedures/
Guides

Organization of cascading training at the central level (trainers for trainers)

Organization of cascade training for the local level (for inspectors)

skills (simulated inspection), identifying gaps, corrective actions

Organization of targeted information campaigns

Organization of training for business operators

Creating and maintaining a register of certificates about the availability of sufficient knowledge and skills



Are there any market operators in Ukraine that already adhere to EU standards for well-being?

Facilities that export livestock products comply with EU standards for animal welfare, in particular during slaughter.





Implementation of standards

The CA implements standards on animal welfare during slaughter by implementing a roadmap for the implementation of standards on animal welfare during slaughter and monitoring business operators' compliance with welfare requirements



Monitoring and evaluation

The competent authority monitors and evaluates the effectiveness of animal welfare standards during slaughter by analyzing the official reporting forms received from the territorial authorities of the competent authority.

What data on animal welfare during slaughter do you collect and how?

Information on the number of slaughterhouses, the number of state control measures carried out and inconsistencies were revealed during the measures of the state control.

Information is collected by receiving reports from the territorial bodies of the competent authority
