Background

- First EU legislation on protection of animals during transport was Directive 77/489.
- Welfare of transported animals started to be more regulated in the early 90s.
- In 1999 the protocol of the EU "Amsterdam Treaty" defined animals as sentient beings.



Council Regulation (EC) No 1/2005 on the protection of animals during transport

Scope: live vertebrate animals transported in connection with an economic activity.

General technical rules

- No weak or sick animals
- Means of transport
- Loading, unloading and handling

Specific rules

- Journey times and resting periods
- Space allowances
- Additional rules for long journeys
- Livestock vessels and sea containers



Regulation (EU) 2017/625 on official controls

OCR repeals the Articles on checks and inspections of Regulation 1/2005


Art. 21 sets requirements related to animal welfare:

- Official controls by the Competent Authorities at all relevant stages;
- Actions and notifications in case of non-compliance;
- Allows for development and adoption of tertiary legislation:
 - Performance of official controls, administrative assistance, verification of AW at borders etc.
 - Use of indicators and measurables on AW, unified frequence of official controls etc.




Tertiary legislation on livestock vessels

 Commission Delegated Regulation (EU) 2023/842 on official controls of livestock vessels



- Mutual teams of inspectors;
- Port State control rules;
- Visual evidence of inspections.

 Commission Implementing Regulation (EU) 2023/372 on the recording, contingency plans, approval of livestock vessels and on exit points



- Electronic database;
- Recording certificates of approval and inspections;
- Contingency plans;
- Vet on board during 1st journey;
- Control post near the exit point.



Council Regulation 1255/97 on staging points

- Requirements for feeding, watering, accommodating and resting of animals for at least 24 h.
- Compulsory approval by Member States competent authorities.
- Annex with specific criteria:
 - A. Health and hygiene measures (i.e. complete cleaning every 6 days)
 - B. Construction and facilities
 - C. Operations



Commission proposal for new Regulation

Background:

- Current legislation remains unchanged for 20 years;
- Scientifc and technological progress has evolved;
- EU citizens' expectations are high;
- Need for modernisation and simplification;
- Commission new proposal adopted on 7 December 2023.

Key new requirements:

- Reduced journey times;
- Increased space allowances;
- Wider digitalisation and real-time traceability;
- Stricter rules on export;
- Equivalent rules at import;
- Other (i.e. sanctions etc.)

Commission Study on digitalisation

- Study on modalities for the use of new technologies and digitalisation to facilitate the implementation and enforcement of rules on animal welfare during transport
- Duration one year
- Focus on the full digitalisation of administrative tasks associated with transportation of animals





EU Liason bodies on animal transport

- Former network of EU National Contact points on animal transport
- Annual meetings in Grange, Ireland (last meeting on 27-28 November 2024)
- Agreement to set two subgroups aimed to produce guidance documents on:
 - Animal welfare during the transport by roll-on roll-off vessels
 - Animal welfare during the transport by air.
