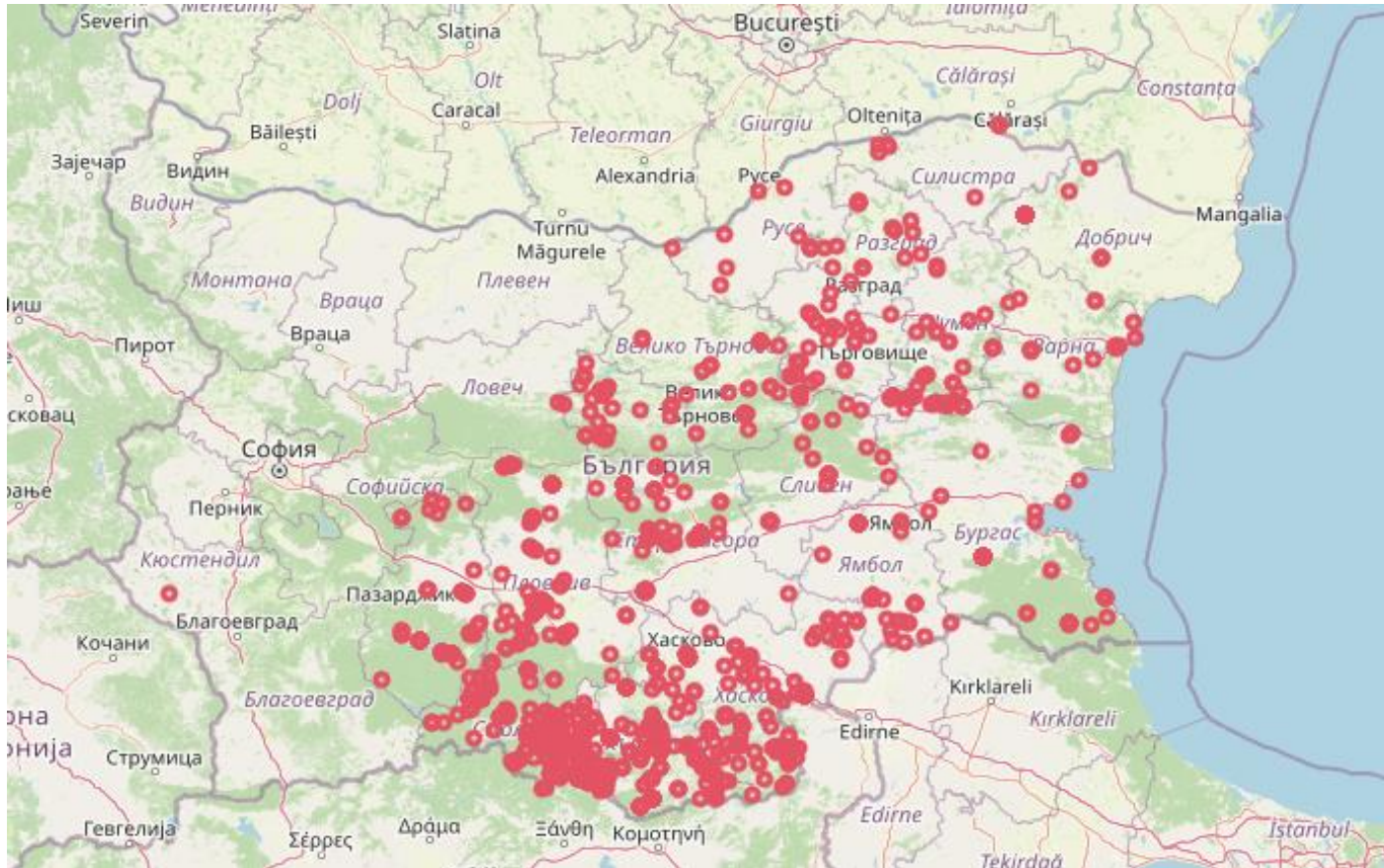

Cases in wild boar – country map

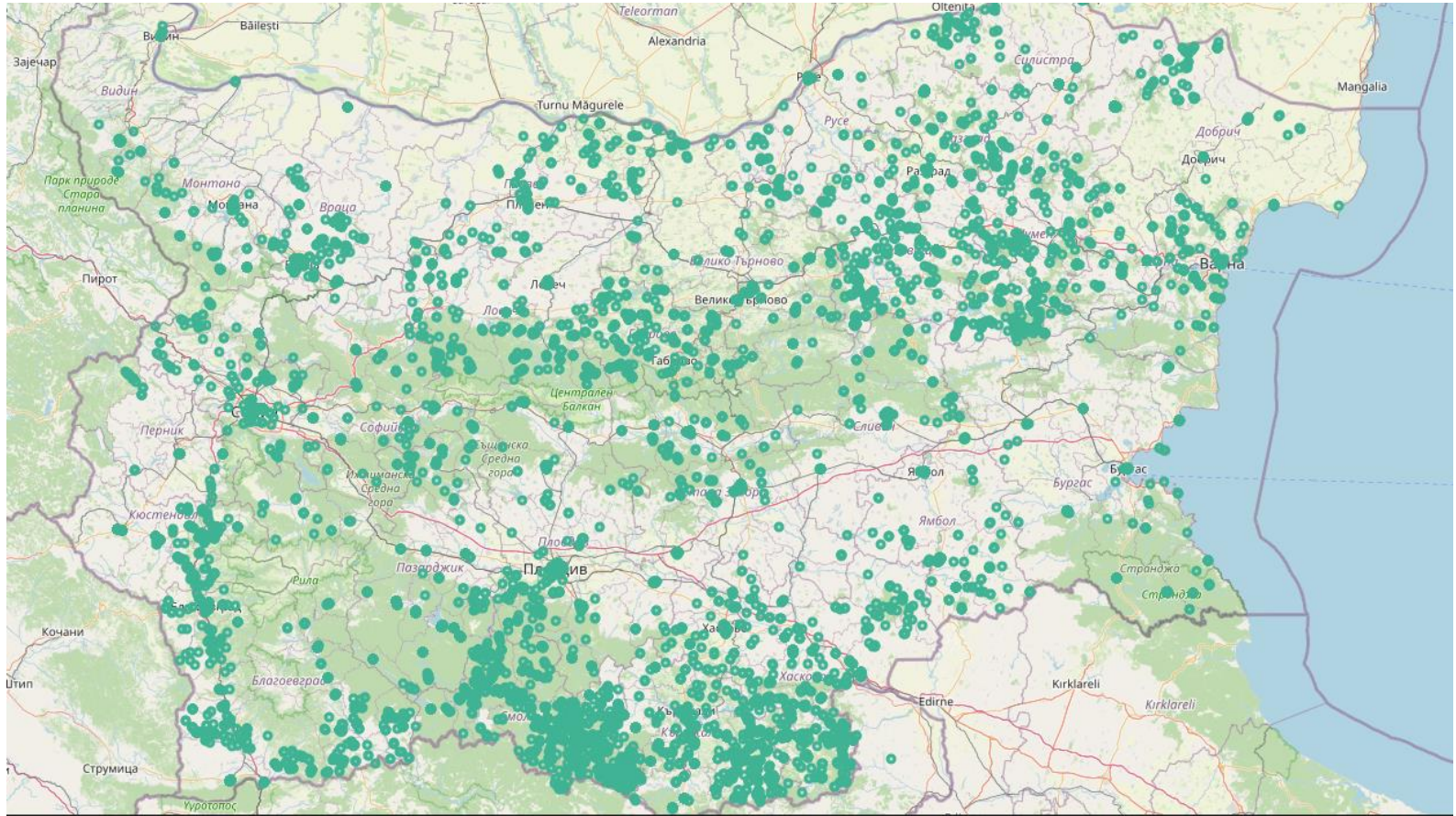

Outbreaks in domestic pigs – country map

Period considered (*ideally 1st April 2024 – 31st March 2025*)

- For the given period 1st April 2024 – 31st March 2025 in Bulgaria are not registered new outbreaks concerning ASF.
- For the specified period in domestic pigs, 13,644 PCR tests were also taken and conducted, all of which were shown negative.
- Also for this time in domestic pigs, 2232 ELISA tests were taken all of which with the same negative results.
