#### **GF-TADs**: A framework for collaboration on TADs control

- Joint FAO and WOAH initiative launched in 2004 for progressive control of Transboundary Animal Diseases (TADs).
- European regional branch established in 2005 to respond to regional crises.
- Encompasses 53 European members, including Western, Southeast, Eastern Europe, and Central Asia.
- Encourages creation of regional alliances and common vision for priority TADs.






- 1. Establish strategies for priority TADs at the sub-regional, regional and global level.
- 2. Develop and maintain capacities to prevent and control TADs.
- 3. Improve sustainability of strategies to control priority TADs through multidisciplinary partnerships.



  - Highly Pathogenic Avian Influenza (HPAI)
  - Lumpy Skin Disease (LSD)
  - Peste des Petits Ruminants (PPR)
  - Foot and Mouth Disease (FMD)







#### 11th Regional Steering Committee

#### **Key outcomes included:**

#### 1. Re-election of the Leadership:

- Dr Van Goethem re-elected as President and Drs Herzog (Austria) and Basiladze (Georgia) were elected as Vice-Presidents for the next four years.
- Permanent Secretariat functions will be ensured Dr Plavsic,
  WOAH Regional Representative.

#### The West Eurasia FMD Roadmap (GF-TADs)

- Date & Location: Baku, Azerbaijan 25 27 April 2023
- The vision for the West Eurasia Roadmap for Foot-and-Mouth Disease Control:

The regional cooperation among West Eurasian countries for the progressive control of FMD leading towards freedom of clinical disease by 2027 for regional economic development, food security, and poverty alleviation.

- Outcomes of the meeting:
- Updated membership of the Regional Advisory Group for West Eurasia (2023-2025);
- Overview of global and regional FMD situation and vaccines recommendations;
- Results of Self-Assessment Tool;
- Results of FMD Vaccines and Vaccination Survey;
- Provisional West Eurasia FMD Roadmap for 2027;
- 9th West Eurasia FMD Roadmap Meeting Recommendations







#### FMD activities under the GF-TADs umbrella in Europe

#### RAG meeting within the FMD Roadmap West Eurasia activity

• Date and venue: July 2-4, 2024, Baku, Azerbaijan



#### Outcomes of the meeting:

- ✓ Support in preparing dossiers for official recognition of freedom status;
- ✓ Consider financial support for RAG meetings;
- ✓ Invite chairs of other RAGs to share experiences on RAG activities and the PPR eradication process;
- ✓ Support countries in ensuring transparency in sharing PPR data (WAHIS);
- $\checkmark$  Encourage countries to request a PBC mission that includes a specific PPR component;
- ✓ Priority translation of PMAT into Russian;
- ✓ Support countries in preparing dossiers for approval of official PPR control programs and official recognition of freedom status for PPR;
- ✓ Invite other countries in the region to participate in global efforts to control and eradicate the disease (Afghanistan).



## <u>Information</u> Webinar on the <u>FMD</u> situation in certain Member States of the <u>European</u> Union

- Date & Location: April 7, 2025, Online.
- Key Message: Separate FMD incursions occurred in Germany, Hungary, and Slovakia in early 2025. Small areas of few EU Member States were affected.
- Outbreaks Highlights:
  - Germany (January 2025): single outbreak involving water buffaloes. Virus Serotype O (O/ME-SA/SA-2018 lineage), 100% genetic match with a Turkey 2024 strain. WOAH official status reinstated!!
  - <u>Hungary & Slovakia</u> (March 2025): several outbreaks, primarily near the Danube River. Virus Serotype O (O/ME-SA/PanAsia-2ANT-10 lineage), showing 100% genetic identity between strains found in both countries.
  - Epidemiological Finding: FMD incursions in Germany and Hungary/Slovakia were epide miologically distinct and unrelated.



## <u>Information Webinar on the FMD situation in certain Member States of the European Union</u>

- Response Principles:
  - Commendable transparency.
  - Immediate, well-coordinated national and EU-level actions.
  - Strict application of international standards.
- Control Measures:
  - Regionalization measures and strict standstills implemented.
  - Robust passive surveillance for early detection.
  - Germany: stamping-out policy.
  - Hungary & Slovakia: stamping-out and emergency suppressive vaccination.
