- Joint FAO and WOAH initiative launched in 2004 for progressive control of Transboundary Animal Diseases (TADs).
- European regional branch established in 2005 to respond to regional crises.
- Encompasses 53 European members, including Western, Southeast, Eastern Europe, and Central Asia.
- Encourages creation of regional alliances and common vision for priority TADs.










- The Second Action Plan for the region, building on previous work and aligning with the global GF-TADs Strategy 2021-2025, covers the period 2023-2027 and includes six main priority diseases:
  - African Swine Fever (ASF)
  - Rabies
  - Highly Pathogenicity Avian Influenza (HPAI)
  - Lumpy Skin Disease (LSD)
  - Peste des Petits Ruminants (PPR)
  - Foot and Mouth Disease (FMD)







# 11th Regional Steering Committee

Date&location: October 1, 2024, Samarkand, Uzbekistan

**Key outcomes:** 

- **1. Re-election of the Leadership**: **Dr Van Goethem** re-elected as President and **Drs Herzog** (Austria) and **Basiladze** (Georgia) were elected as Vice- Presidents for the next four years.
- Permanent Regional Secretariat: Dr Plavsic, WOAH RR for Europe.
- 2. The continuing **challenges** of TADs in Europe and Central Asia was highlighted, as well as the need for **coordinated**, **collaborative and innovative solutions within the GF-TADs** framework.







# Standing Group of Experts (SGE) on ASF

## SGE-ASF23:

- Date & Location: September 18–19, 2024, Ohrid, North Macedonia.
- Focus: cross-border cooperation (CBC).
- Outcome/Recommendations: CBC should be improved with the identification of strength (e.g., formal agreements, shared resources) and weak factors (e.g., lack of transparency, insufficient funding).

## SGE-ASF24:

- Date & Location: April 3–4, 2025, Sarajevo, Bosnia and Herzegovina.
- Focus: biosecurity in pig establishments, especially in high-risk small non-commercial pig farms.
- Recommendations:
  - countries should improve biosecurity measures in all pig farms and different sectors; enhance laboratory biosafety; clearly provide a definitions for "backyard" farms.

#### Contribution to the 3<sup>rd</sup> meeting of the Global Coordination Committee for ASF - 29 May 2025, Paris

## **Meeting objectives:**

- Review progress of the Global Initiative for ASF Control (2020–2025) and discuss the strategic focus and technical priorities for the next (2026–2030).
- Capture regional strategic priorities to foster cross-regional collaboration and tailor fit-forpurpose solutions.

#### **Conclusions:**

- The Global Initiative provides a framework for FAO–WOAH collaboration, fostering data sharing, best practices, and alignment with regional needs.
- Advocacy, capacity building, and regional/national strategies remain priorities, with emphasis on practical, field-level solutions.

# Position of GF-TADs Europe on the Proposal for the strategic focus of the Global Initiative:

- Global Initiative actions overlap with existing GF-TADs regional framework, therefore it has a limited added value for Europe;
- The Global Initiative should focus on concrete, field-level results.
- Europe remains committed to supporting other regions, sharing expertise and lessons learned, while strengthening national capacities through existing mechanisms.





# 6<sup>th</sup> Standing Group of Experts on Rabies (SGE RAB6):

Date & Location: July 11, 2024, Brussels, Belgium (hybrid event).

**Focus**: Main pillars of rabies elimination: Oral rabies vaccination campaigns (ORV), surveillance and cross-border cooperation.

#### **Outcome/Recommendations:**

- Three new countries Moldova, Poland, and Ukraine were included as full members of the SGE RAB.
- The coordination in planning and executing ORV campaigns between neighboring countries, particularly improving the timing to enhance their effectiveness, enhancing the information exchange and strengthening passive surveillance were highlighted.







# 2<sup>nd</sup> Standing Group of Experts (SGE) on HPAI (SGE2):

Date & Location: September 30, 2024, Samarkand, Uzbekistan.

#### **Objectives**:

- Epidemiological situation (worldwide, including mammals),
- Review risk management practices (USA, Finland, France),
- Discuss HPAI strategy, surveillance, biosecurity, vaccination, and zoning.

#### **Outcome/Recommendations:**

- The meeting highlighted increasing global HPAI outbreaks and spillover to mammals, emphasizing the need for robust surveillance, vaccination, and international collaboration.
- France vaccination campaign was a success.
- Finland's One Health response was successful.
- Developing safe and effective HPAI vaccines.








# **Standing Group of Experts (SGE) on LSD**

- SGE LSD -13: 21<sup>st</sup> Feb 2024 (Online).
- SGE LSD -14: 5<sup>th</sup> Mar 2025 (Online).



Participants: WOAH, FAO, EC, EuFMD, LSD reference lab experts, country representatives.

#### **Outcomes:**

- LSD effectively controlled in Southeast Europe since 2019 via coordinated mass vaccination.
- LSD situation in Central Asia remains unclear.
- SGE on LSD meetings suspended until concerned countries in Central Asia show clear commitment and willingness to engage.



# Peste des petits ruminants (PPR) – two webinars

- 4th September 2024 and 5th March 2025, PPR situation in Europe region under GF-TADs
- Participants: WOAH, FAO, EC, EuFMD, PPR GEP Secretariat, PPR reference lab experts, country representatives.

## Outcomes: emphasis placed on:

- Enhanced surveillance
- Disease awareness
- Risk assessment
- Sample sharing with Reference Labs
- Transparency and information sharing
- Enhanced diagnostic capacity







# Information Webinar on the FMD situation in certain Member States of the European Union

- Date & Location: April 7, 2025, Online.
- Key Message: Separate FMD incursions occurred in Germany, Hungary, and Slovakia in early 2025. Small areas of few EU Member States were affected.
- Outbreaks Highlights:
  - Germany (January 2025): single outbreak involving water buffaloes. Virus Serotype O (O/ME- SA/SA-2018 lineage), 100% genetic match with a Turkey 2024 strain. WOAH official status reinstated!!
  - Hungary & Slovakia (March 2025): several outbreaks, primarily near the Danube River. Virus
     Serotype O (O/ME-SA/PanAsia-2ANT-10 lineage), showing 100% genetic identity between strains found in both countries.
  - Epidemiological finding: FMD incursions in Germany and Hungary/Slovakia were epidemiologically distinct and unrelated.





# Information Webinar on the FMD situation in certain Member States of the European Union

# Response Principles:

- Commendable transparency.
- Immediate, well-coordinated national and EU-level actions.
- Strict application of international standards.

#### Control Measures:

- Regionalization measures and strict standstills implemented.
- Robust passive surveillance for early detection.
- Germany: stamping-out policy.
- Hungary & Slovakia: stamping-out and emergency suppressive vaccination.



UPDATE: "FMD-free country where vaccination is not practised" status of Hungary is GF-TA reinstated as of 10 September 2025.





# Information Webinar on Peste des petits ruminants (PPR) and Lumpy Skin Disease (LSD)

- 3rd July 2025, LSD and PPR situation in Europe region under GF-TADs.
- Participants: WOAH, FAO, EC, EuFMD, PPR GEP Secretariat, LSD and PPR reference lab experts, country representatives.

#### **Outcomes:**

- Updated epidemiological situation shared on PPR and LSD in Europe
- National responses presented by Albania (PPR), Italy (LSD), and France (LSD)
- Scientific insights from EU Reference Laboratories
- EU support reaffirmed: technical guidance, expert missions, vaccine bank, financial assistance
- FAO and WOAH contributions highlighted: training, simulation exercises, webinars, virtual learning
- Regional cooperation emphasized under GF-TADs for coordinated prevention and control
- Consensus on vaccination as the cornerstone of LSD control; urgency for mass vaccination in Italy and France
- Need for continued transparency, awareness, preparedness,
- Strong participation (200+ attendees)
