

Statement of Intentions (SOI) agreement - improve cooperation in preparedness and control of FAST diseases in the Transcaucasus and neighbouring territories





Statement of Intentions (SOI) Agreement

- First agreed upon in 2016 by Armenia, Azerbaijan, Georgia, Iran, Türkiye and the Russian Federation
- In 2024, Iraq and Pakistan were formally included

Common vision

- intensified collaboration in the prevention and control of FMD and similar TADs
- improved confidence in effectiveness of control programmes implemented
- reduced risk of epidemics in the region

Included activities

- sharing of risk information
- monitoring and surveillance of FMD and similar TADs
- organization of multi-country simulation exercises
- organization of yearly joint planning committee meetings aimed at reviewing the activities implemented and identifying priorities

Statement of Intentions (SOI) Agreement

Priorities 2025/26

- Maintain and improve reporting system of outbreaks and vaccinations and improve risk information sharing including digitisation of reporting
- Improve regional understanding of the risks posed by FMD and other FAST diseases and support mitigation efforts
- Progressively implement an Early Warning surveillance
- Promote preparedness and control through participation in training and proficiency tests
- Monitor the effectiveness of vaccination (e.g. SSIS, vaccine strain recommendations)
- Improve national capacities for risk mapping



SAT2 activities - diagnostics and vaccination


- Protocol for sample shipment and laboratory support established between Türkiye and Iraq
- Emergency procurement of laboratory kits for SAT2 (Ag ELISA, SP ELISA, PCR reagents for Armenia, Azerbaijan, Georgia, Iran, Iraq, Türkiye)
- Adaptation and provision of PCR protocol
- Vaccine matching, selection of candidate vaccines, identification of suppliers
- Mediation of dispatch of SAT2 vaccine from the EU vaccine bank to Türkiye and Georgia

Small-scale immunogenicity studies in Trans Caucasus countries


- Vaccination against SAT2 in the region began 2023 and is ongoing
- Small scale immunogenicity studies currently underway in Armenia, Azerbaijan and Georgia
 - Regular FMD vaccines used in region including SAT2 are tested
 - Serum samples will be collected up to 180 days p.v.
 - Sera will be analysed in national laboratories (NSP/ SP ELISAs) and at the IZSLER Brescia (VNT)

SAT2 activities - communication and training

- SAT2 preparedness and control in SEEN: bi-weekly coordination meetings (SEEN countries, EuFMD, FAO, WRLFMD, IZSLER, ARRIAH, Sap), until December 2023.
- Diagnostic and epi trainings:
 - Training on FMD diagnosis, 15-26 May 2023, at IZSLER, for Iraq and Jordan
 - Training on molecular techniques for FMD diagnosis, 3-7 July 2023, at ANSES
 - FMD Investigation training course in Turkish in 2023
- Webinars, incl. FAO SAT2 webinar series, EuFMD & Razi Institute
- Promotion of EuFMD open access courses (incl. Introduction to (1) FMD, (2) FMD Minimum Biorisk Management Standards, (3) Animal Health Surveillance) and non-open access courses (Vaccines, Vaccination and PVM 2023)
- Awareness & information material for countries




Likelihoods based on questionnaire data from official veterinary services in the 21 target countries other data from the literature, FAO STAT

Risk pathways	Likelihoods*	Reasoning	Uncertainty
live animal movement - legal trade	Low - negligible	depending on recent trade activities; control measures in place, in general relatively low volume of trade	Moderate - high
- informal trade	High - negligible	depending on volume of informal trade and FMD status of trade region, emergency SAT2 vaccination in area	High
- common grazing	High - negligible	depending if practiced or not, frequency/timing, extent of FMD spread, emergency SAT2 vaccination in area	High
legal and informal trade in POAO	Low - negligible	depending on volume of imported POAO; most likely processed	Moderate
movement of wildlife between countries	Low - negligible	focus on wild boars; wild boar population present; SAT2 proximity to border; shared grazing pastures	Low - high
movement of people between countries	Low - negligible	magnitude of people movement accross borders; time SAT2 remains viable on e.g. clothes	High
Legal and informal trade in fodder	Low - negligible	sanitary measures in legal fodder; contamination/survival/contact all need to occur	High
movements of vehicles	Low - negligible	focus on animal transport vehicles; frequency of cross border transport; contamination/survival/contact all need to occur	High

SOI database

- Monthly reporting of outbreaks of FMD and other FAST diseases including email notification of reported outbreaks
- 3-monthly reporting of progress of vaccination and market prices for livestock and meat

Group for Vaccination Advice, Guidance and Consultation (GVA)

- 6-monthly GVA meetings with SEEN countries
- Post vaccination monitoring and small-scale immunogenicity studies
 - Evaluation of immune response to FMD vaccines
 - Assessment of vaccine quality and suitability



Meeting with vaccine manufacturers to discuss SAT1 vaccine availability and evidence of efficacy,
 June 2025
