# LSD epidemiology – evolution since SGE LSD6 (Paris May 2018)

- Third annual vaccination (revaccination) - BovivaxLSD-N
- Procurement of 900.000 (700.000 +200.000 +...?) doses of vaccine
- LSD vaccination started on 1.4.2018. in risk area (zone 1) and in zone 2 after ending of BTD vacc.accoring to Plan of vaccination of LSD and BTD in 2018.
- Until now, 77% of cattle are vaccinated.








#### LSD vaccination in 2018. (CDB on 15/10/2018.)






2017 Number of holdings 2017 Vaccinated animals



#### Pharmacovigilance / side effects of LSD vaccination

- Procedure in place (2017)
- Paper form designed
- Structured information
  - Detail analysis to be carried out
  - Available early 2018
  - Reporting: 22 reported side effects of LSD VACCINATION
  - (abortions, deaths...) from begining of 2016.
  - ALL SIDE EFFECTS ARE COMPENSATED



### Specific Plans for 2019

- Meeting of Expert group on 15.10.2018.
- **Conclussion:** LSD vaccination in 2019 will be continued according to:
- Epizootiological situation in the region and in the country
- Surviellance of the vectors and presence of LSD virus?
- If LSD vacc. **will be continued** a new **plan will be adopted** according to Program of measures for 2019.
  - Plan A: Vaccination of complete cattle population.
  - Plan B: Vaccination of all new born calves (after 6.months ages) and new imported cattle on whole teritory and vacc. of all cattle in zone 1


Plan C: Vacc. of all new born calves (after 6.months ages) and new imported cattle only in zone 1


