1. Support of Member Countries of the OIE Regional Commission for Europe to the projects identified under the FAO/OIE GF-TADs

Considered:

Priority diseases for Europe : FMD, AI, CSF, Rabies, PPR

Recommended:

Support to the establishment of RSUs in neighbouring regions (Northen Africa, Middle East and Central Asia)

=>identification of primary endemic areas through lab and epidemiological networks



2. The role of wildlife in the spread of highly pathogenic avian influenza

Considered:

- -Spread from South East Asia to Southern Europe
- -Infections in wild birds and possible links with occurrence of the disease in poultry
- -Scientific data on the role of wildlife

- -Active surveillance (domestic poultry and wild birds) and biosecurity measures according to risk assessments
- Sharing of scientific information and virus isolates to trace their origin; collaboration with OFFLU
- -Preparation/update emergency management & risk communication plans
- -Assistance to countries at risk; support Vladimir lab to become OIE/FAO ref lab for AI
- -Early detection, rapid response, farmers compensation
- -Quality of VS considered a priority



3. Prevention, control and eradication of rabies in Europe

Considered:

- -Re-emergence of rabies in some European countries
- -New scientific and technical knowledge for prevention/detection of rabies
- -Need to assist countries to control/prevent the spread of rabies

- -Implementation of rec. of OIE 1st Intl Conf on "rabies in Europe" *(Kiev, June 2005) => epidemiology, rabies diagnosis, animal rabies control, human rabies prevention, vaccinology/immunology, bat rabies
- -Provision by EC+ other bilateral donors of technical assistance to affected countries of the region
 - * this topic was further developped during the Joint OIE/WHO/EU Conference on rabies toward the elimination of rabies in Eurasia held in **May 2007** in Paris



4. Collaboration between existing networks on activities related to animal health

Considered:

- -Inadequacy of funding of research in animal diseases in some Europ. countries
- -Need for proper coordination mechanism for optimal use of available resources
- -Need for broadened collaboration in research

- -Promotion of collaboration among OIE/FAO/EC Ref. Labs
- -Increase of networking by OIE/FAO/EC Ref. Labs and Coll. Centres; seek support of EC & other reg/intl organisations to this purpose
- -Essential role of Russia & other bordering countries to protect European region from pathogens from other GF-TADs regions
- -Support by EC to OIE/EC national seminars (in all 25 nonEU Members of the region)



2d GF-TADs SC FOR EUROPE – Paris, 18 December 2007 RECOMMENDATIONS

1. Support to Regional Animal Health Activities under the regional GF-TADs Mechanism

Considered:

- -Need for VS compliant with OIE intl standards for animal disease prevention and control
- -Frequent (re)emergence of serious intl animal health crisis; re-emergence of ASF, emergence of bluetongue; necessity to achieve the goal of the GREP
- -Importance of regional networks; of integrating the control of animal diseases/zoonoses (incl. neglected) in the global context
- -Support to be provided to mechanisms such as GLEWS and CMC-AH; to many OIE Members for prevention/control of animal diseases (incl. zoonoses)

- -Reinforcement of VS after evaluation with OIE-PVS Tool; support of FAO, EC; dissemination of communication strategies on sound VS governance/crises risk management by Adv.Com.of OIE AHW Fund and FAO, WHO, WTO
- -Reinforcement of support to prevention/control of anl diseases programmes by OIE, FAO, donors (as EC) and assistance by GLEWS and CMC-AH to Members
- -Engagement of OIE Ref. Labs of the region in twinnings; support of FAO, EC
- -Review/adaptation of vet. training curriculum (compliance with Dir 2005/36/EC); support of EC
- Participation of WHO in GF-TADs Regional SC meetings; FAO/OIE/WHO support combating of pathogens at their animal source to prevent transmission to humans



2d GF-TADs SC FOR EUROPE – Paris, 18 December 2007 RECOMMENDATIONS

1. Support to Regional Animal Health Activities under the regional GF-TADs Mechanism (cond)

- -Preparation of emergency plans for bluetongue, ASF, HPAI in all European countries; review of zoonoses control plans (incl. rabies); studies intensified on preventive and control measures; + ref. to HPAI conf in New Delhi, OIE/FAO future global conf. on FMD, EC future conf. on Bluetongue vaccination
- -Members' support to GREP to seek global free Rinderpest status
- -Members's review of their animal health budget (incl. compensation); disease surveillance in all natl territories; strengthening identification/traceability capacities for bov, ov, cap, por; development of public/private partnership for animal health & food safety systems; review/monitor upgrading of food-processing plants (incl. residue controls); review of legislation on vet. pharmaceutical products; review of organisation & functions of Vet. Stat. Bodies; review system of vet. border control (anls & anl products); review of approach on animal welfare standards



2d GF-TADs SC FOR EUROPE – Paris, 18 December 2007 RECOMMENDATIONS

2. Support to the Control of ASF and CSF under the Regional GF-TADs Mechanism

Considered:

- -ASF & CSF outbreaks reported in several Eastern European countries and Balkan region; risk of spread to other countries
- -Need for appropriate surveillance & early warning programmes in neighb. countries; necessity of sound governance of VS; need for countries at risk to mobilise resources to counteract the diseases using vet. inspection at borders

- -Urgent reinforcement of VS of countries affected (Caucasus) after an OIE-PVS evaluation to be followed by a PVS-Gap analysis (in collaboration with FAO and EC / submission to international donors, incl. EC for financial support)
- -Funds made available for ASF be also used when appropriate for control of FMD
- -Control measures for CSF in Balkan region be overseen by OIE Reg/Sub-Reg Representations for Europe, in coll. with FAO
- -OIE Ref. Labs to provide guidance to countries at risk in the surv. of ASF, CSF and FMD
- -Making Governments of East European countries aware of the urgent necessity to provide resources to VS, in particular for vet. border controls, and compensation of farmers; OIE letter to relevant Ministers of concerned countries
- -Compliance with prompt reporting obligations of animal diseases to OIE (=> WAHID)

GF-TADs for Europe

The GF-TADs (Global Framework for the progressive control of Transboundary Animal Diseases) is a joint FAO/OIE initiative which combines the strengths of both organisations to achieve agreed common objectives. It is a facilitating mechanism which endeavours to empower regional alliances in the fight against transboundary animal diseases (TADs), to provide for capacity building and to assist in establishing programmes for the specific control of certain TADs based on regional priorities. It has been signed on 24 May 2004, in relation with the general Agreement signed the same day between OIE and FAO. >>View the document

Since December 2007, the GF-TADs Steering Committee for Europe is chaired by Dr Van Goethem, Head of Animal Health and Welfare Directorate in DG SANCO (European Commission). An update on on-going and planned actions was made at the occasion of the 77th OIE General Session on 25 May 2009. >>View the document
