1. Global perspective

Budget 2016

- Statutory contributions:
 - Each country free to choose the category
 - 58% countries in Cat 6
 - 80% countries in Cat 4-5-6
 - 60% contributions come from countries in Cat 1-2-3

Budget 2017

• Budget voted for 2017 = 10,485,000 euros / revised = 10,152,000 euros

Challenges

- Decrease in the overall regular budget
- Increased mandates:
 - New topics (e.g. AMR)
- New expectations under the 6th strategic Plan:
 - Strengthening of OIE international standard setting procedures and of the scientific risk assessment for status recognition procedures
 - Modernisation of WAHIS (WAHIS+)
 - Operation of the RR/SRR, considered as an essential network for the OIE to deliver its core missions
 - Investment in OIE HR management and the IT masterplan

Challenges

 Core missions heavily funded through voluntary contribution (volatility) [WARNING]

> Increasing the Statutory Contributions has become a necessary investment

• To increase statutory contributions by 20%

Increase of statutory contributions:

- To be proposed to the World Assembly meeting of May 2017
- To be implemented as of 2018 if adopted

Proposal

Challenges:

- Many governmental Authorities have issued national rules refusing any increase in contributions to International Organisations
- Drastic reduction in their own VS budget
- Timing!
- But OIE's activities at stake, otherwise:
 - several priority needs not be properly covered
 - some activities at risk of being postponed
 - some activities at risk of being cancelled


