Objective for the EDFZ

- 5th Asian Indoor and Martial Arts Games in Ashgabat, September 2017
- Originally 19 sports, but Goresh (traditional wrestling) and equestrian (jumping only) were added and accepted by Olympic Committee
- MoA requested OIE for support and 2 experts assisted the SVS from June 2016 to September 2017
- TM is not on the list of regionalised countries for the EU, but some participating nations wanted to bring their horses from EU
- → Need for an EDFZ and regionalisation by EU of the EDFZ

Description of EDFZ

- Core zone: Ashgabat hippodrom
 - Resident horses (400) were removed 6 months before the Games
- Surveillance zone covers most of TM's Akhal Theke horses:

S. A. A.

- 110 km in South along the border with Iran
- 55 km in NW bordered by a water canal and district border
- 157 km in North bordered by a soiled water canal
- 30 km in SE by bordered by district border
- Total of 4000 km²

The Veterinary Services

- Established sind 2012
- > Under MoA, headed by a Director (CVO), oversees:
 - Central Vet Lab and Vet Units in 4 regioans and 50 districts
 - Vet Inspection Services for Borders and Transport
 - Scientific Research Experimental Vet Lab
 - SVS in Ashgabat and 5 regions
 - SVS in 50 districts (etraps) and 16 cities (shehirs)

Turkmen Atlary

• Specific to TM is the existence of a « Ministry of the Horse »

- Has offices at central, velayet and etrap levels and owns stud farms
- Deals with Akhal Theke breeding, registration of holdings and identification of horse
- Turkmen Atlary law of 2015 obligation to register horses
- Actively engaged in setting up the EDFZ





Preparatory work to set up EDFZ

Census

- Akhal Theke horse are registered, micro-chipped and branded.
- Others are registered and mainly used as border inspection horses
- Numbers have increased to over 5000
- 3878 horses, 599 camels, 112 donkeys, 6 kulans in surveillance zone
- Ongoing disease surveillance by SVS
 - Glanders
 - Surra

- in TM 7 hippodromes
- brucellosis ____

• Surveillance plan was set up for « 6 diseases » identified by OIE as important for international Horse movement


Series of active surveys

- 1. survey in November 2016
 - All sampes tested at Central Vet Lab; aliquots sent to Dubai (glanders, AHS, surra), Germany (EI)
 - Results: negative for AHS, EI, EIA, glanders, surra
 - Positive for surra in 3 camels
- 2. survey in February 2017
 - AHS and EI excluded
 - All samples tested at Central Vet lab; aliquots to Dubai (glanders, surra)
 - Positive piroplasmosis results in horses and donkeys
- 3. Survey in June 2017
 - Horses only, no more camels
 - All samples tested at CVL; positive piroplasmosis in horses and donkeys

Passive surveillance

Increased passive surveillance on all private and state owned horse farms during the period November 2016 to after the Games in September 2017 (by SVS and TA)















International quarantine

- The IQC was newly constructed and finished in November 2016
- Can hold 120 horses, world class, state-of-the art standard
- 6 barns, each with paddock and exercise area
- Common race course and jumping & dressage arena
- Veterinary clinic
- Horses from non-EU approved third countries resided at the IQC for 3 weeks, one barn per country











Biosecurity

- Detailed biosecurity plan:
- Horse arrival, transport by air and road
- Inspection on arrival
- Biosecurity of the venue
- Biosecurity at the IQC
- Vector control
- Cleaning & disinfection
- Contingency plan



International Health Certificate

Veterinary Certificate for the Temporary Importation of horses into Turkmenistan to compete in the equestrian events of the 5th AIMAG

Le anto

- Developed in line with HHP (OIE) principles and in line with EU requirements
- > Additional certificates for movement:
 - Enter the surveillance zone from TM territory
 - Enter the Core zone from the surveillance zone
 - Move from IQC to Core zone
 - Move from IQC or Core zone to Equine hospital

Self-declaration of EDFZ to the OIE

- Dossier was prepared and submitted to the OIE in June 2017
- > OIE published self-declaration of freedom in the EDFZ for (AHS), glanders, EIA and EI, in August 2017

Official carrier for AIMAG (Peden Bloodstock) produced *Equestrian Freight Manual* on the basis of the EDFZ declaration



Regionalisation of EDFZ with EU

EU questionnaire for regionalisation was prepared and submitted to DG SANTE in February 2017

It was accepted and published in EU Official Journal as:

Commission Implementing Decision 2017/862 of 17.5.2017

In parralel with the EDFZ self-declaration, TM submitted the dossier for declaration of freedom from AHS

Le antal

- Dossier was not approved (lack of capacity of SVS to survey for and detect AHS)
- Dossier was meant to be resubmitted > ???????
- > Objective: to declare the IQC a permanent EDFZ and to have it regionalised by EU
- Would allow its use for the region for purpose of quarantine, competitions, stop-over
