


# Domestic pigs surveillance – Sept-Dec 2019






# Outbreaks in domestic pigs – Sept-Dec 2019

### New measures enforced in the beginning of 2020

### Legislative:

- Amendment of the Law on Veterinary Activities
- ✓ easier registration
- better veterinary supervision (by private vets) in smaller holdings
- strengthening the local cooperation with institutions
- ✓ new compensation rules
- Amendment of the Ordinance on the requirements for animal holdings
- ✓ strengthening the biosecurity requirements
- ✓ Individual biosecurity plans for holdings
- ✓ Individual CP for holdings
- Amendment of the Ordinance on expenditure related to epizootic risks

#### **Operational:**

- National standstill in the beginning of 2020, gradually lifted over time
- Permanent Official vet presence in all industrial farms
- New SOPs for repopulation of holdings and on official controls in holdings
- Follow-up checks in depopulated backyards

### Strategic:

 Multi-institutional plan for control and prevention against ASF adopted in January 2020 by the Council of Ministers
