# **BACKGROUND**



## COUNCIL DECISION – OCTOBER 2020

- Council provided with a discussion paper providing two scenarios for 2021 GS:
  - Hybrid
  - Virtual agreed option
- OIE General Rules (Basic Texts) does not preclude the possibility for the General Session to be held remotely
  - Art. 39 "Except when the Assembly at a previous session, or in exceptional circumstances the Council, decides otherwise, the Annual Session of the Assembly shall be the held in the month of May in Paris."



## AAR LESSONS LEARNT – 2020 ADAPTED PROCEDURE

## GOVERNANCE - GENERAL

- The organisation of the GS is coordinated through a Steering Committee –
  General Session Steering Committee (GSSC)
  - Composition on next slide
- The GSSC defines the overall approach to the preparation and holding of the next General Session → virtual
- The GSSC reports to the ExCom and consult other institutional bodies as need be
- The GSSC meets at least once a week

# **APPROACH**





## APPROACH - GENERAL

- The GS will be held through a series of 5 virtual sessions of no more than 4 hours each starting at around midday Paris time
  - Dates From Monday 24 to Friday 28 May 2021
- This time is not sufficient for allowing all the presentations nor for addressing all the resolutions usually presented for adoption during a presential General Session
- There is thus a need to develop a web portal part of the GS Website where:
  - Some presentations/videos will be uploaded in advance
  - Members will be able to send comments/questions on some documents before GS
  - Members will be able to vote on some resolutions in advance (status, Ref. Centres, Diagnostic Kits, among others)





## PRE-GENERAL SESSION INFORMATION WEBINARS

- In order to ensure the timeliness of the technical virtual sessions (mainly standards), it is proposed to hold information webinars some weeks before the GS.
- These meetings will be an opportunity for the regional members of the Specialist Commissions to explain the standards put for adoption and to gather the general feeling back to the Presidents and OIE Secretariats
- Based on this information, the Presidents of the respective Specialist Commissions would have a greater understanding of what they must focus on during the GS discussions
- Some standards where it is felt that a consensus would be difficult to reach could be drop.

- General Session Opening & Address of Government Authorities: March 21 May
  - Open the OIE's 88<sup>th</sup> General Session and showcase short statements from at least 1 Minister from each OIE region
  - Emphasize the One Health approach and of role of animal health using a storyline format/approach
